on a measure-11 25 year sentence with 15 years
left. I'm a 38 year old father of five. There all
ageing fast with out a father. I claim full
Responsibility for what i have done and I blame
my self for coming to prison. After coming
to prison i have had a reality check on my life
The Difference Between the young minded boy
who came to prison Nine years ago and the
man I have become could never be put on
paper or vocalized By words, my impeccable
performance and Adherence to the rules here
in prison as well keeping a job the hole time.
I have worked my way up to living on the best
Honor unit with 88 inmates all in a Down here
at Two Rivers. most of my unit has over Ten years
of clear conduct some have over 20 years clear
conduct. We Represent the Reformed Inmates
who sincerely and genuinely Deserve Some type
of Acknowledgement. The incentive to get good
time some day has helped me to make changes
to my self so that i mite get to see my kids and
family Sooner. My mom Suzette Lundy has only one kid
yes thats me. And look where im at her only kid
is in prison! The positive changes i have made in
my self is not just for me it's for my kids and my
family as well my town of Salem. This is way more
than just a Request to be set free I needed
prison to make me grow up I really needed that
change in my life. This is for Acknowledgement
for the last 9 years of my life and all the

Clear Conduct that I have gotten Because I Stayed out of all the Negatives of prison and Stayed on track. I have taken any and all class that Two Rivers has. I worked with Staff to start up a class to teach other clear conduct Inmates how to Do art with paint and now the prison is letting us paint art all over the walls in here. I have been very active in helping the handy capt in here as well I am very active in a group study class that gave me a lot of tools and the prison now lets me on my unit teach other inmates the skills so they can change there lives around as well. I have had a job the hole time I have been in here. That's saying a lot because I never stayed at a job for any more than one year when I was out side of prison. I take joy in helping other inmates and some day they will be out of here and around all of us so I can some how help them to become more positive then when they get out there they will have a better chance at the good way of life. I have refused to let me being locked up stop me from Learning as much as I can. "Self made" I don't have money to go to school in here so I just use others school books for learning. I have taken a progressive approach to prison time I do Appreciate all the new skills I have Developed on my own. I feel Because of Oregon's measure -11 and its mandatory minimum sentence. It made prison become a warehouse and not a accountability with opportunities to heal and find rehabilitation for

the inmates who have no direction
It's costing the State of Oregon and
our tax payers
\$108.26 a Day per inmate to keep each
one locked away. That's \$39,514.90 a
year. We should be spending that money
on our schools so our kids don't come
to prison and they get a good chance at life.

Most of you hearing this have no clue
what this is and has done to the people of
Oregon, this is a crippling law and intell your
family personally is faced with it them selfs
Some day which will happen if you dont fix
it today. Measure-11 has touched more than
6,191 at this time in prison now. and 70% of
inmates under measure-11 are first time offenders
thats 4,333 inmates. Measure-11 was made
for Repeat Offenders But the numbers
show different. Most voters have no clue
what measure-11 is. The prosecutor who's
job is to seek justice Not conviction is
in control why?

In 1994 Oregon told all of its judges just to
sit back and let the DA ~~strip~~ Strip there
Discretion and Rights to do there job.

I would like to see justice also because
victims are real. I just dont want to
see enefective mandatory minimums.
Today how the law is Despite being a Honor
inmate there is no difference Between

two inmates with the same time and even the same crime. Lets say theres two of us one inmate is in trouble constantly fighting officers and other inmates and never follows any of the rules and has no job, and never signs up for class.

Then take the other inmate who works all day follows all the prisons rules and stays out of trouble with respect for others and helps out where ever and when ever needed. Lets say they both get out and they live on the same street as you
What one would you rather live beside?

Please Alleviate this problem for all of us who are doing good inside of prison.

Remember just because you give good time it dont mean we all will get out on the same day and it also dont mean we all have the clear conduct to get good time. each six months we get looked at and they track who is doing good. So inmates are high risk some are not. Im one of the low risk ones who always gets told im doing good but nothing else.
