Co-Chair Johnson, Co-Chair Steiner Hayward, Co-Chair Rayfield and Members of the Committee:

On behalf of the Port of Hood River Commissioners, I write to support the Port's \$3.59 million request for American Rescue Plan funds to construct crucial infrastructure on a key 12-acre part of the Hood River Waterfront known as "Lot #1".

Lot #1 is the last significant undeveloped light industrial property on the waterfront. Our local community envisions future development there that will include a mix of light industrial and commercial uses that generate local jobs, and a demonstrated commitment to sustainable design, generous bicycle/pedestrian corridors and active public spaces. The greatest hurdle for achieving this vision is the cost of basic street and utility infrastructure. Preliminary engineering plans to build N. 1<sup>st</sup> Street and E. Anchor Way, and relocate underground utilities are estimated to cost of \$5.09 million. The Port is able to fund \$1.5 million of this total. The balance represents the Port's ARP request of \$3.59 million.

The development potential of Lot #1 is enormous for a community the size of Hood River—over 150,000 s.f. of construction and 400-500 jobs. It would also help fulfill an enduring community vision for the Hood River Waterfront— active, sustainable, walkable, and connecting downtown with the Columbia River. There are many long-term community benefits in achieving this vision.

The Port Commission respectfully requests your support for \$3.59 million in American Rescue Plan funding to develop critical infrastructure for Lot #1. The completed project would deliver significant economic development and job creation, while also bringing significant quality of life benefits to the Hood River community.

### **Illustrative Perspectives**


#### Description

In 2015 the City Council provided significant direction for the development of Lot 1 by adopting a Waterfront Refinement Plan and a Waterfront Overlay zone. Following this direction, the Port provided the 2016 planning effort completed by the Walker Macy team (Lot 1 - Development Plan) which outlined further refinement for future development. This report builds on the previous plan's concepts and further refines the potential appearance and development of Lot 1.
