

Chair Barbara Smith Warner, Vice Chair Drazan, Vice Chair Holvey, and Rules Committee Members,

As a faculty member at Willamette University, I write to support the -18 amendment on SB554. Administrators, faculty, and staff are responsible for the safety of Willamette University students but there is little we can do without support from the City of Salem and the State. Willamette University students have been terrorized by armed protestors on the state capitol grounds and nearby parks.

When students are scared, they cannot focus on their school work, and they cannot learn. Students of color are particularly affected. If they live on campus, which is required for 1st and 2nd year students, students of color are expected to stay in their rooms during protests. This might mean missing a class, campus job, or being unable to visit the library or grocery store. This short-term solution is not good for student mental health, it makes them feel unsupported like we are blaming the victim. We need a broader solution to help students feel safe.

Willamette University has unique challenges because of our proximity to the state capitol. If there's a suspicious package at the capitol or court house, university students also shelter in place. As legislators consider protecting public buildings, please do not leave us out. Voting yes on the -18 amendment would go a long way toward protecting and supporting students, particularly students of color, at Willamette University.

As we noted in an email last Thursday, there is activity at the State Capitol today involving members of the Patriot Prayer group and groups with opposing views. We are providing an update of today's activity so you can be aware and make informed decisions about your travel through the area.

We received an alert that there are about <u>150-200 armed participants</u> on the north side of the capitol and that opposing protestors are expected to arrive soon. The activity has been contained to the north side of the capitol. We encourage you to avoid the area. We have additional security on campus and continue to monitor the area. We will let you know if there are any changes that you should be aware of.

As a reminder, weapons and outside protesters are not allowed on the Willamette campus. If you observe anyone with a weapon, do not approach them. If you have concerns or are in need of assistance, call Campus Safety at 503-370-6911.

As the weekend is upon us, I wanted to provide information in support of the many concerns that members of the community have expressed about safety in light of the racist violence enacted on one of our students earlier this week.

It is understandable that an event like this, that happened so close to campus, would elevate concerns for students' safety. It is important to acknowledge that this is not the first time that people have been feeling unsafe. For BIPOC individuals safety is something not felt for a long time, or perhaps ever.

We have often expressed how living and working across from the Capitol brings both opportunities and challenges by providing a front row seat to watching the democratic process in action. However, this year is different from other years. The political polarization and the racialized rhetoric has become more intense and the activism at the Capitol more dangerous in tone and more extreme.

This heightened threat of violence in the country and at the Capitol have led to concerns and fears. As a result, we provide the following information.

Ride and Escort Services

Student Organized Rides

We understand that students have organized mutual aid ride sharing that has been advertised on Instagram and other social media sites. This is a wonderful testament to the resourcefulness and care of the student body. In addition to these options we want to remind you of some university supported options.

Campus Safety

Campus Safety is available for walking escorts across campus as well as rides as needed, 24/7, when the destination is within a few blocks of campus.

Safe Ride is a ride program developed years ago by ASWU that has become a program operated by Campus Safety in partnership with Willamette Valley Yellow Cab. This program has, in the past, allowed students to call Yellow Cab and have the ride billed to their student account. Because of the extraordinary circumstances this year, Willamette will cover the cost of the cab ride. In order to make sure that this program can be sustained through the end of the semester, we encourage you to limit use of this program for times you are traveling solo to a destination within the immediate Salem area.

To use SAFE RIDE:

- Call Yellow Cab at (503)-362-241. Tell the dispatcher you are using SAFE RIDE.
- Show the driver your valid Compass Card. The driver will enter your name and ID number on a SAFE RIDE form.
- When you arrive, fill out the bottom portion of the form, sign it, and return it to the driver.

Safety Tips

We can't say enough that the solution to ending violence does not rest with those who have experienced the violence. However, many have asked for us to share some safety reminders:

- Avoid walking alone at night. Ask a friend or call campus safety for an escort or use Safe Ride if needed.
- When you are on campus, know where emergency telephones are along your route. Here's a <u>map</u>.
- Pay attention to your surroundings. Walk briskly.
- Have your key ready before getting to the door.
- Visually check inside, around and under your car before getting in, then lock all doors and roll up windows.

Future Plans

As President Thorsett shared in this week's Words from Waller, we are exploring opportunities to connect the Willamette community and leaders in the Salem community to come together to engage in important conversations about racism and to begin to develop collective strategies for action. Students, staff, and faculty have begun planning for this event, and more information will be shared in the coming weeks. Peace.
