

Your gun control bills have nothing to do with safety of anyone. You and your minions want to control the population. Look at this history from David Babet:

"No permits or licenses were required to carry a concealed weapon in the supposedly more civilized Northern states until fairly recently. In contrast, concealed weapon bans were fairly common in the supposedly gun slinging and dueling world of the South and West.

[9] carrying concealed weapons appeared in Kentucky as early as 1813. Indiana followed in 1819 and by 1850 every Western state had prohibited carrying a concealed weapon. In comparison New Jersey had only one gun law (prohibiting dueling) in effect prior to 1924. No licenses, permits, or other measures were needed to buy, own, or carry a weapon. This was indicative of most Northern states until recent times."

He goes on to write how this was tied into the economic issues of the time:

"The public began to rally behind such legislation since these organizations managed to convince them that gun control would keep gun-wielding immigrants at bay and reduce crime. Most people were unaware that these anti-immigrant groups were founded and supported by factory owners and other capitalists who realized that an unarmed workforce of immigrants would have a difficult time unionizing in the face of weapon wielding strike breakers."

Babet looked at WHICH GROUP the power structure targeted in each period of time and it was usually tied into economic issues but...it's always specific groups. Blacks, Italians, Irish, Mexicans, etc. Not color of skin so much but economic issues? So it looks like the avalanche of gun control bills in Oregon is because Democrats do not like Constitutional Conservative Republicans. That seems the targeted group in this moment in history. The Oregonians who grow our food, have ranches, get wood for us to build houses, truckers who get food and other supplies to us, have wives and children they love and care for...kind of salt of the earth folks.

More from Babet: " More significantly, during the first three years of the Sullivan Law over 70 percent of people arrested for its violation had Italian surnames.²⁹ Despite its shortcomings, the idea of police issued gun permits spread throughout the United States. Between 1911 and 1934 Arkansas, Hawaii, Michigan, Missouri, New Jersey, North Carolina and Oregon all passed laws similar to the Sullivan Law.³⁰ The 1920 Ohio Supreme Court case of *State v. Nieto* upheld the conviction of a Mexican man who was convicted of carrying a concealed weapon while he was lying in his bed.³¹ California and New Hampshire went as far as banning aliens from owning firearms. In both states the law was challenged in court and in both states the bans were upheld.³² "

When the Black Panthers walked around Oakland with their guns in 1967...by 1968 lynchings of both black and white men stopped.

Babet: "The Gun Control Act of 1968 was passed at a time when the Black Panthers were making headlines by openly and legally carry weapons during their demonstrations. Muckraking journalist Robert Sherrill, a strong proponent of stringent gun control says, "The Gun Control Act of 1968 was passed not to control guns but to control blacks..."
