Re: Information on the Rent Guarantee Program and the Housing Choice Landlord Guarantee Program

Dear Chair Jama, Vice-Chair Linthicum, and Members of the Senate Committee on Housing and Development:

Thank you for hearing <u>House Bill 2101</u>, which makes programmatic changes to ease barriers for landlords in accessing the Rent Guarantee Program (RGP) and the Housing Choice Landlord Guarantee Program (HCLGP). These programs are vital to removing barriers for high-risk low-income Oregonians in accessing housing, as they provide landlords with the financial assurance to rent to individuals who may have evictions on their record. During the hearing, a few questions were raised about HB 2101:

Senator Anderson asked after the need for more funding for the program:

Both of these programs have sufficient funds to operate under the expansion in this bill. So far, there has not been significant fiscal impact in administering these programs. With the Rent Guarantee Program, only 6 claims have been paid out over the lifetime of the program.

Senator Anderson asked after the reach of the program:

OHCS partners with multiple service providers to serve 23 Oregon counties, below you will find a list of the counties and the organizations that serve them. OHCS recently expanded this program to Baker, Grant, Marion, Polk, Union, and Wallowa Counties through new partnerships with Community Connections of Northeast Oregon and Mid-Willamette Valley Community Action Agency, and hopes to expand to more counties in the future.

Additionally, our partner Transition Projects is working on an online course for the Rent Guarantee Program that will launch this summer in seven languages. This was made possible by legislative investments in Rental Market Resources during the 2019 session. However, many smaller agencies have capacity concerns with operating these programs in person, as classes take resources and staff to administer. Expanding programs to smaller communities may require additional investment.
