My name is Heidi Hagler and I live [...]. in Corvallis. We live in the Oak Creek Valley, in Chinook Road District near Fitton Green Natural Area and our fire services are provided by the Corvallis Rural Fire Protection District (CRFPD). We have one public road leading in/out of our road district and one long gravel trail which can be used as an evacuation route. The community has conducted research on appropriate evacuation opportunities based on the population in the Oak Creek Valley and determined that the routes currently available are not sufficient, especially given the nature of the rural-urban interface and the growing danger of wildfire.

Recently the CRFPD was asked to consider participating with community donors and the County, in funding an additional evacuation route for the Valley, through OSU property. OSU had signed an MOU to allow use of the land and the County had agreed to maintain the route and help fund it. The missing piece was CRFPD which was asked to pay 1/3 of the cost, which was \$150,000, out of the district's nearly \$4 million in unallocated funds. The District declined the opportunity on the basis that the state regulations did not explicitly permit districts like CRFPD to participate in evacuation activities. My personal feeling is that this was a reckless and misguided decision that could cost people their lives. Approval of SB 863 will clarify for Districts all over the state that their role in fire safety can include evacuation activities such as funding or helping to fund evacuation routes.

We are writing to express our strong support for <u>SB 863</u>, the bill that would amend the Oregon Revised Statutes (ORS 478.260) to allow Rural Fire Protection Districts (RFPD) to participate in the development of emergency evacuation routes.

We live in the Oak Creek Valley, an unincorporated rural community of 380 households, northwest of Corvallis. It is located in a large forested basin or Wildland-Urban-Interface (WUI) and has **only one public exit** – **Oak Creek Drive**. In an emergency evacuation, this clearly insufficient single public exit would also need to accommodate traffic from the many people who recreate in the Oak Creek Valley at OSU's McDonald Forest and the Fitton Green County Natural Area.

Earlier this year, the Corvallis Rural Fire Protection District Board (CRFPD) declined to support a badly needed alternate emergency evacuation route in the Oak Creek Valley, citing the lack of statutory authority to do so. Passing SB 863 would provide the CRFPD with the statutory authority they need to participate in potentially life-saving evacuation route development for the Oak Creek Valley.

But SB 863 would not just directly benefit residents of the Oak Creek Valley; it would benefit rural residents throughout the state.

The Oak Creek Valley is representative of similar situations occurring in Limited Access Neighborhoods across the state. As the danger of large-scale wildfires increases annually, the need for safe evacuation routes also grows. SB 863 provides an option for ALL Oregon RFPDs to participate in rural evacuation route development.

We support SB 863 because it will help save lives, not just in our community, but statewide.

The need for this has become abundantly clear, as exurban neighborhoods that sprang up decades ago prior to the enormous increase in wildfire risk now face a dearth of evacuation options.

Our community has been working hard to prepare for wildfire, forming Firewise Communities when support exists to do so and following many of the prescriptions when that support has gone unfunded. We have worked together to share information about how to reduce risks, and fought to have Benton County recognize and address the risks by designating evacuation routes. We are one of some 40 limited-access neighborhoods in Benton County alone.

We are facing the need to pay for evacuation routes to get our 400 households to safety, and we are finding that there are few options to pay for this. Meanwhile, Rural Fire Protection Districts have funds that can be spent on aspects of fire preparedness that do not match the current reality- for example, building water tanks to deal with single-structure fires, not preserving life in a wildfire event.

This bill can help address a critical public safety need and save lives throughout the rural communities in our state. I live in a limited access neighborhood that would directly benefit from SB 863. There is only one road out of our small valley of 380 households (Oak Creek Valley northwest of Corvallis). So I am writing to urge you to support SB 863, a legislative amendment that would allow Rural Fire Protection Districts to participate in the development of emergency evacuation routes. The Corvallis Rural Fire Protection District Board declined to support development of our community's badly needed emergency evacuation route earlier this year, citing the lack of statutory authority to do so.

It makes no sense in my mind that the Corvallis Rural Fire Protection District, which is tasked with protecting life and property in our valley, cannot help further that goal by helping to ensure that there is an alternative to the single exit we currently have. Fire could easily block that single exit route (there is a power substation right in the middle of the narrowest section of the exit road, making this an even higher risk). In fact it seems obvious to me that all Fire protection districts should not just be authorized but required to help establish fire evacuation routes. Particularly limited access neighborhoods like ours!

Providing explicit language in the ORS for Rural Fire Protection Districts to participate in potentially life-saving evacuation route development is therefore greatly needed. Oak Creek Valley is one of 40 Limited Access Neighborhoods in Benton County and of course there are many others in the rest of Oregon. This bill would improve chances of fire survival across all of Oregon – as we saw last summer, large and fast moving fires are becoming more common all over the West due to our changing warming climate.
