RE: HB 2002 – Transforming Criminal Justice.

Good afternoon Chair Smith Warner, Vice Chairs Drazan and Holvey, and members of the Committee,

Thank you for the opportunity to submit testimony today in strong support of transforming criminal justice. For the record, my name is Elona J Wilson, and I am the Advocacy Director at the Coalition of Communities of Color, an alliance of <u>culturally specific community-based</u> <u>organizations</u> with representation from African, African American, Latinx, Middle Eastern and North African, Native American, Pacific Islander, and Slavic communities in Oregon.

After the murders of George Floyd and Breonna Taylor there has been an outcry from community for intentional and meaningful criminal justice reform. This is not the first time that we have had a Black Lives Matter movement, but we are committed to making this the last. The last time that Black and brown lives matter any less than others. The last Black and brown lives stolen by those who say they protect and serve. After Mike Brown was murdered in 2014, commitments to police reform and accountability were made that never came true. That is unacceptable and will not happen again.

We are not done yet, and we cannot allow for this movement to die down and for people to forget yet again that Black lives do indeed matter. We must make lasting change, real change, intentional change, so that we do not repeat history. That is why I am asking you to support HB 2002.
