Co-Chairs Frederick, McLain and Members of the Committee,

I write today on behalf of the more than 750 members of the Beaver Caucus to ask that you fully fund OSU's Statewide Public Service Programs so that the university can fulfill its mission as Oregon's land-grant university.

The OSU Statewides, which include the Extension Service, Agriculture Experiment Stations and Forest Research Laboratories, provide vital support and services to communities in every county in Oregon. The Governor's Recommended Budget flatlined the Statewides funding. We are asking you to support \$158.5 million in operational funding for the OSU Statewides - \$84 million for the Agricultural Experiment Station, \$61.9 million for the OSU Extension Service and \$12.6 million for the Forest Research Laboratory. This investment represents a 7.42% base funding level increase from the 2019-21 budget so the OSU Statewides can continue their essential work in Oregon.

This investment will preserve programs in your community, and across the state. The return on investment for these programs is immense. Please support the OSU Statewides during the 2021 legislative session.

The OSU Extension Service has been a huge help to me in learning about and changing forest practices on our family's little forest here in Cove, Oregon.

I am writing in support of increasing the funding for OSU Extension and the Statewide Services.

How have they been so helpful? OSU Extension sponsored multiple webinar series for small forest land-owners during the past two years. In short, these webinars have been of great quality and their topics well thought out. As a person with a medical condition that makes me "at-risk" for serious illness (actually death) if I were to get infected with the COVID, the webinar format has been perfect.

In the webinars, different professors present relatively detailed information about most every aspect of owning a small forest. The opportunity to ask any question – and getting reliable answers – is great! The series has been nothing short of outstanding!

Despite having an undergraduate degree in Forestry myself (long time ago), I learned a tremendous amount and have made many, many changes to how I manage our family's 32 acre forest:

1. Reducing the risk of devastating wildfire changed how I both prune and thin Ponderosa Pine on our hillsides. I now thin some tree species more aggressively and others less so in achieving newly-learned prescribed forest densities. I also prune our P-Pines higher up so that "fuel ladder" risk is minimized.

2. Learning about the devastating impacts of the Ips bark beetles has been particularly interesting. First, I thought that Ips only infested true-Fir species. Once I learned that Ips can and do infest Ponderosa Pines, it was revealing because for years I could not figure out why some of our small pine trees were dying! It was these damn Ips beetles! Once I learned the Ips beetle's life cycle and infestation targets, I realized that I was causing these infestations because I would leave pine slash on the ground exactly during spring and summer when the Ips would "fly" and infest! Last year, I changed when I prune – and have not lost a single tree since then!

3. Enhancing wildlife habitat is particularly important to our family because Union County has allowed sub-dividing the former cherry orchards into 10 acre tax parcels while completely disregarding wildlife impacts. Near our family forest, two new big houses have been built and another is coming. These new homes have significantly and negatively impacted elk and deer herds in the eastern areas of Cove and the Mill Creek drainage. Herds just don't migrate to their usual feeding and mating areas when there are people, house and roads now intruding into their habitat. Also, it feels like the local quail, wild turkey and forest grouse populations have thinned out a lot in recent years.

What could I do to help counter these negative impacts? OSU Extension taught me the proper forest density and age-management techniques that are conducive to healthy wildlife habitat. My adjoining forest landowner

neighbor and I have joined with other forest landowners nearby and have started consciously managing the woods as a "unit" for wildlife habitat enhancement. We are intentionally leaving snag trees, downed logs, and more understory. We are hoping our efforts result in larger elk and deer herds, and many more birds.

4. Learning about tree diseases and forest insects has been eye-opening. From root rot and mistletoe to bark beetles, needle borers, and defoliators - there are dozens of organisms that feast on our NE Oregon forests! I now am able to identify these diseases and pests more readily which has changed my thinning and pruning practices in order to reduce tree mortality and increase forest health. Also, learning about diseases and pests has been personally gratifying – I can recognize them while hiking and hunting our magnificent NE Oregon forests whereas before I would just wonder why "all these trees were dead" or dying. It's great.

There is so much more that I have learned from the OSU Extension webinars. I really urge more funding for this wonderful service as I want them to continue this educational outreach to the public, and hopefully have the resources to visit my family's forest to advise us how to better manage our little forest for future generations. Also, their help in making use of prescribed burning for small forest landowners is really going to be helpful – to reduce the ever-increasing risk of severe fire to our little forest – and the entire eastern slope of Mt. Fanny.

Enhancing wildlife habitat is particularly important to our family because Union County has allowed sub-dividing the former cherry orchards into 10 acre tax parcels while completely disregarding wildlife impacts. Near our family forest, two new big houses have been built and another is coming. These new homes have significantly and negatively impacted elk and deer herds in the eastern areas of Cove and the Mill Creek drainage. Herds just don't migrate to their usual feeding and mating areas when there are people, house and roads now intruding into their habitat. Also, it feels like the local quail, wild turkey and forest grouse populations have thinned out a lot in recent years.

What could I do to help counter these negative impacts? OSU Extension taught me the proper forest density and age-management techniques that are conducive to healthy wildlife habitat. My adjoining forest landowner

neighbor and I have joined with other forest landowners nearby and have started consciously managing the woods as a "unit" for wildlife habitat enhancement. We are intentionally leaving snag trees, downed logs, and more understory. We are hoping our efforts result in larger elk and deer herds, and many more birds.

4. Learning about tree diseases and forest insects has been eye-opening. From root rot and mistletoe to bark beetles, needle borers, and defoliators - there are dozens of organisms that feast on our NE Oregon forests! I now am able to identify these diseases and pests more readily which has changed my thinning and pruning practices in order to reduce tree mortality and increase forest health. Also, learning about diseases and pests has been personally gratifying – I can recognize them while hiking and hunting our magnificent NE Oregon forests whereas before I would just wonder why "all these trees were dead" or dying. It's great.

There is so much more that I have learned from the OSU Extension webinars. I really urge more funding for this wonderful service as I want them to continue this educational outreach to the public, and hopefully have the resources to visit my family's forest to advise us how to better manage our little forest for future generations. Also, their help in making use of prescribed burning for small forest landowners is really going to be helpful – to reduce the ever-increasing risk of severe fire to our little forest – and the entire eastern slope of Mt. Fanny.

So, I've been following the droughts we've been having in Oregon these last few years. We're in a moderate drought condition right now, March 17th, in the Eugene area. Check out drought.gov and see where we are now. Point is, the Willamette Valley farmers grow a lot of things, food being one, and if we're going to keep being productive, we need to figure out how to deal with drought impacts on farmers -- and the people who depend on them -- for food. Extension has been doing research with farmers, reaching out to farmers, to do just that, by using dryland farming techiques. Last year, in my backyard garden, I tried different ways of growing and not using much water, with the idea of potentially developing working hypotheses that could potentially be tested scientifically.
