RE: OSU Statewide Public Service Programs

Dear Senators Johnson and Steiner Hayward and Representative Rayfield,

Our diverse coalition would like to share the importance of the Oregon State University Statewide Public Service Programs – the Agricultural Experiment Station, Extension Service, and Forest Research Laboratory – to the State of Oregon. Known as “The OSU Statewides,” these programs provide state-of-the-art research and outreach generated by scientists and extension agents to real-world problems.

Since March of 2020, these programs have responded to the realities of COVID-19 by adapting and innovating to continue addressing community and state needs. This fall, they also pivoted to serve the immediate needs of communities and economic sectors. The examples are numerous.

OSU Extension rose to meet the challenges of 2020 in several areas. They are providing COVID-19 education and outreach for all residents, particularly those in traditionally harder-to-reach communities, such as the Mam-speaking community in Lincoln County. They collaborated with the Oregon Army National Guard and Oregon Department of Agriculture to distribute 915,000 KN95 masks and 5,000 gallons of hand sanitizer for agricultural workers in 18 counties. During the Labor Day fires, Extension employees and volunteers, especially in our 4-H program, worked day and night rescuing livestock, then caring for the animals at more than a dozen county fairgrounds. 4-H programs have been there as an anchor for our kids despite the pandemic and other disasters. Extension also helped coordinate hay donations for farmers and ranchers with fire damage. The new Extension Fire Program presented post-fire webinars that drew hundreds of attendees.

The Agricultural Experiment Stations across the state recognize that research is essential to the continuity of the state’s food production lines. The experiment stations quickly prioritized policies and procedures to protect researchers from COVID-19 while still allowing them to continue critical work with crops, livestock and even offshore on boats. When smoke filled the state at the time of wine grape harvest, food science researchers created a process to test grapes and wine for impacts of smoke exposure. The Oregon Wine Board recognized this work with the 2021 Industry Partner Award.

Scientists and foresters with the Forest Research Laboratory continue research in areas like forest management and fire resilience in newly adapted formats as the risk of wildfire does not stop with COVID-19. More than a dozen researchers are probing the 2020 wildfires’ aftermath in a range of ways. Researchers are conducting stream studies in multiple western and southern Oregon watersheds and looking at fire’s ramifications for biodiversity in a collection of southwestern Oregon forests. They are also assisting in post-fire forest planting and planning, including addressing and discussing questions around seed availability and appropriate seed zones, climate mitigation, and availability of seedlings. Additionally, modular mass timber structures, developed from OSU research, can be used as fire hardened housing or as temporary housing.

The Governor’s Recommended Budget flatlined the Statewides funding. We are asking you to support \$158.5 million in operational funding for the OSU Statewides - \$84 million for the

Agricultural Experiment Station, \$61.9 million for the OSU Extension Service and \$12.6 million for the Forest Research Laboratory. This investment represents a 7.42% base funding level increase from the 2019-21 budget so the OSU Statewides can continue their essential work in Oregon.

We acknowledge the unique state of Oregon's economy and recognize the difficult decisions you will have to make in the months ahead. As a critical part of OSU's Land Grant mission is to serve all corners of the state, we see this as a time to invest in programs, like the OSU Statewides, with a significant statewide impact.
