

OBOP has histograms by which they intend to convey information.

I have histograms as well. This is one I UPDATED in August 2012. It is considerably out of date and SOME things have changed, but it is still useful.

The colors of the bars on the graph are matched with numbers in the table. There is a key provided for the pairings.

It is easy to spot immediate differences among the Oregon Mental Health license-types by looking at the histogram.

Looking to the table, I especially encourage you look at series 3, 6, and 7.

Although it is easy to see that the numbers are higher overall for Psychologist Associates as compared to other Master's Prepared license-types, a closer look shows that there are many measures on which the requirements for Psychologist Associates exceed Doctorally Prepared Psychologists.
