**Subject: Mosier Testimony for May 7 Public Hearing in Favor of SB 5534**

Dear Honorable Committee Members,

On behalf of the community of Mosier, Mayor Arlene Burns, Mosier City Council, Chief Mike Renault, Fire Board President Phil Evans, and the Mosier Fire District Board, I am submitting the attached testimony in favor of Senate Bill 5534 with a funding request for the new **Mosier Center – Fire Station/Community Center/City Hall**.

Key reasons to support our project:

- Our request is for \$750K, 11% of the project. This support would bring us to 57% funded. This support PLUS a Fire District pending loan or bond of \$1.3 million brings us to 77% funded.
- The project improves Mosier Fire District's service capacity not only for our own district, but the entire region, as evidenced in Mid-Columbia Fire and Rescue's letter of support (LOS)– attached.
- We have the support of Wasco County as evidenced in the County Commissioners' LOS
- Schematic design is complete, and we will soon begin construction documents. A general contractor has been hired through a CMGC RFP process. We are near shovel-ready.
- This project is well supported by the community, many of whom are in volunteer firefighter and leadership positions. A quiet campaign for major gifts is underway. A more general campaign for smaller gifts will follow when the project is 80% funded or better.

Along with letters of support, I have included a project description and funding budget showing our funding assets in hand, as well as the breakdown of what we plan to raise. We are extremely grateful for this opportunity and look forward to the successful passing of the bill. Please feel free to contact me if you have questions about the project.

*A 'net zero' facility to support regional safety & economic vitality in the heart of the Gorge*



**Regional Fire & EMS Support** Mosier is a small but growing and increasingly diverse community that supports The Dalles & Hood River as well as other communities in the region via Mutual Aid agreements. Mosier Fire also regularly assists accidents along I-84, at rest stops and within Memaloose State Park. This facility will provide much needed space for ongoing fire and medical training. It is also slated to be the first certified net zero fire station in the country.

*After a 2016 oil train derailment, 2017/18 Memaloose I & II fires and 2020 Mosier Creek, Dry Creek and Seven Mile fires, the City of Mosier and Mosier Fire District have recognized a dire need for community resilience. We are now more determined than ever to build the "Mosier Center" with state of the art emergency and public services.*



**Ability to serve as 'Command Central' for Emergencies** Mosier Fire has hosted several conflagrations in the last decade including the Microwave Fire in 2011, the Oil Train Derailment in 2016, and subsequent Memaloose fires in 2017/18 and the lethal Mosier Creek fires in 2020. With growing fire dangers in the area we are likely to host more in the coming decades. The location is also a key communications check point in local emergency plans.

**Regional Tourism / Economic Development** Located on the Historic Hwy, the new center will provide information, restrooms & services for the 2 million tourists who travel through the Gorge each year. These numbers grow each year and doubled after the Eagle Creek Fire pushing hikers and bikers East to our area.



**History Museum / Community Gathering Space for Wider Valley & Regional Partners** Mosier is the civic and social hub for over 2000 residents and many community organizations in the wider Mosier valley. The new building will include a home for the Mosier Valley Historical Society's collection of photos and artifacts as well as visitor center, meeting spaces and kitchen use.

**Food Pantry & Emergency Shelter** Especially after Covid-19 economic impacts, food insecurity is an issue in the Gorge and 98% of the region's food is shipped in by truck. These facilities provide the public with a **Resiliency Hub** in case I-84 is closed off for an extended period.


Wasco County supports City of Mosier and Mosier Fire District's joint Mosier Center construction project to house a new fire station, city hall and community center.



Hood River and Mosier, as adjacent communities, are vital mutual aid partners in emergencies and disasters, that we've seen escalating in recent years: COVID, Mosier Creek Fire, Rowena Fires, Sevenmile Hill Fire, White River Fire, Fir Mountain Fire, Holloway Fire, Warm Springs fire, Eagle Creek Fire, 2012 and 2017 Winter Ice Storm, 2015 and 2020 drought.

Our small and rural communities face particular challenges due to lack of resources and staffing, and can only make demonstrable improvements in community services with the infusion of grant funding.

Sadly, our communities also face vastly increasing future risks, according to the August 2018 OCCRI (Oregon Climate Change Research Institute) study for Oregon Department of Land Conservation and Development, *Climate Change Influence on Natural Hazards in Eight Oregon*

Counties<sup>1</sup>, Wasco and its adjacent counties Hood River, Sherman, and Gilliam:

- Wildfire: Across all eight counties, wildfire risk projected increase of 38% greater frequency by 2050, compared to historical baseline.
- Heat waves: Extreme heat events are expected to increase in frequency, duration, and intensity due to continued warming. Extreme heat event increase: 12 additional days at or above 90 degrees.
- Hottest day of the year is projected to increase by 8 degrees by 2050 compared to historical baseline
- Drought: Counties like ours, reliant on spring and summer snowpack to supply summer water demands, will experience more frequent drought conditions in Wasco and Hood River Counties.

The City of Mosier is the eastside gateway to the Mark Hatfield Twin Tunnels Trail and several important hiking and bicycle routes along the Historic Highway, including the Mosier Plateau Trail, Memaloose State Park, and the Rowena Crest Trailhead. For this reason, the new Mosier Community Center will provide key resting and wayfinding facilities for tourists traveling through the National Scenic Area and support the economic goals of our region.

The Historic Columbia River Highway Advisory Committee supports the City of Mosier's application for funding the Mosier Center Complex, including the Plaza and Bike Hub in downtown Mosier.

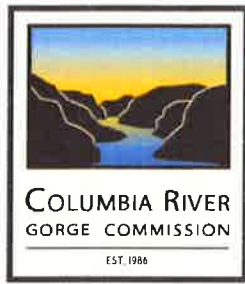

Dear Senator Findley and Representative Bonham,

Travel Oregon's vision is a better life for all Oregonians through strong, sustainable local communities that welcome a diversity of explorers. This includes enhancing economies throughout the state to help communities better leverage the state's multi-billion-dollar tourism industry. It also means working together for community improvements that will support a safe and enjoyable visitor experience and enrich the quality of life for Oregonians. As such, we support the Mosier Joint Fire/Community Center project.

The popularity of the Columbia River Gorge is increasing as tourists seek outdoor recreation and culinary experiences. Between 2016 and 2017, 3.3 million visitors stayed overnight in the Mt. Hood-Columbia Gorge region. Countless visitors traveled along I-84, passing by or stopping in Mosier. Mosier is home to scenic hiking trails including the Mosier Plateau and Rowena Crest Trailhead and is the eastside gateway to the Historic Columbia River Highway State Trail. Visitors also enjoy high-quality wine and culinary experiences, with Mosier as the focal point of the recently developed East Gorge Food Trail, highlighting 30 culinary businesses.

The joint fire/community center will provide key resting and wayfinding facilities for visitors traveling in the Columbia River Gorge, supporting the local tourism economy. Additionally, the center will increase public safety and provide a resource in the event of an emergency situation or wildfire.

Travel Oregon strongly prioritizes efforts to reduce wildfires and their associated negative economic impacts. The Mosier community has felt the impact of wildfires over the past four years. In 2017, the community experienced the 2017 Eagle Creek Fire. In 2018, Wasco County faced wildfires that heavily impacted the Lower Deschutes River, in turn impacting the local outdoor recreation economy. In 2020, the Mosier Creek Fire threatened approximately 300 homes and burned nearly 1,000 acres. Communities must be prepared to respond and ensure safety for all who are located within their boundaries. An improved fire station will help mitigate potential wildfire impacts in Mosier and the surrounding area.

In 2017, Oregon experienced a \$51.5 million loss in visitor spending attributable to wildfires; Wasco County alone experienced a \$2.59 million loss. These losses can be detrimental to the vitality of communities that depend on tourism dollars to boost local economies. The Mosier Joint Fire/Community Center project will serve as a hub for visitors, but more importantly, result in increased public safety and wildfire mitigation, ensuring the area can remain open to visitors and continue to strengthen the local tourism economy.
