Re: Support for Washington County Family Peace Center project (SB 5534)

Dear Co-Chair Girod, Co-Chair Holvey and Members of the Committee:

I am writing to express my support for the Washington County Family Peace Center project.

As District Attorney for Washington County I recognize the urgent need to increase the resources and support for victims of child abuse and domestic violence in our community.

For the past two years I have led a work group of community members to address this issue. Together, we developed a concept called the "Washington County Family Peace Center." Our goal is to co-locate a child advocacy center (CARES Northwest) along with a domestic violence center (Family Justice Center) so that we can provide a coordinated and multidisciplinary response to victims of child abuse, neglect and domestic violence. The attached document provides further description of this project.

Our workgroup has identified a building for this project that we anticipate will be available for purchase in late 2021. As an example of the enormous community support for this effort, attached is a packet of over 60 letters of support from organizations, elected officials and individuals. These letters were collected last September as our workgroup engaged in discussions with Washington County regarding a potential building site.

Washington County Family Peace Center

A campaign for our community

THE VISION

- To establish a state-of-the art facility for Washington County children and families impacted by child abuse, neglect and domestic violence.
- To provide medical treatment, therapy, family support and prevention services to address trauma in a collaborative, proactive way while promoting the health and safety of our community.

THE PROBLEM

Child abuse and domestic violence are widespread

- Approximately 1 in 7 children experience child abuse or neglect annually.ⁱ
- Approximately 1 in 4 women and 1 in 10 men experience domestic violence during their lifetime.ⁱⁱ
- In 2019 Oregon had 89,451 reports of child abuse including 23 fatalities.ⁱⁱⁱ

Child abuse impacts everyone, but disproportionately impacts BIPOC children

- Approximately 50% of the Washington County children treated for child abuse identify as non-white (top categories are Hispanic/Latino-30% and multi-racial/ethnic-36%).^{iv}
- Approximately 66% of the Washington County children treated for child abuse are financially vulnerable (either no health insurance or on Medicaid).^v

Harm caused by child abuse and domestic violence is long-lasting and expensive

- Childhood trauma (known as Adverse Childhood Experiences or “ACEs”) increases the likelihood a person will experience mental health challenges, difficulty with school or employment, addiction, homelessness or criminal behavior.^{vi}
- The cost of domestic violence over a victim’s lifetime is estimated to be \$103,767 for women and \$23,414 for men.^{vii}
- The cost of child abuse over a victim’s lifetime is estimated to be \$830,928 per victim, including costs for healthcare, child welfare, criminal justice, special education and lost work productivity.^{viii}

Washington County’s child population is growing

- 139,603 children live in Washington County, representing approximately a quarter of the county’s entire population.
- Washington County has the second largest child population in Oregon, with only 13,210 fewer children than Multnomah County
- Within the next two decades, Washington County is projected to have the largest child population in Oregon.

Washington County does not have a dedicated facility for child abuse victims

- The primary medical clinic serving Washington County child abuse victims, CARES Northwest, is located in Northeast Portland, requiring up to a two-hour roundtrip drive per appointment.^{ix}

- CARES Northwest was established in 1987 primarily to serve Multnomah County children.
- Beginning in 2018 and reversing a 30-year trend, ***CARES Northwest now serves more Washington County children than Multnomah County children*** (treating approximately 800 Washington County children annually).

COVID-19 has harmed victims of child abuse and domestic violence and reduced reporting

- From March to December 2020 during the pandemic, 31% fewer Washington County children were seen at CARES Northwest.
- In 2020, reports of child abuse in Washington County dropped by over 50% as schools closed and teacher contact with children was limited.
- In 2020, domestic violence in Washington County increased along with stress and social isolation caused by the pandemic.

THE SOLUTION

- Community members and leaders have been working together over the past two years to co-locate CARES Northwest with the Family Justice Center in a single Washington County location called the “Washington County Family Peace Center,” to serve children and families in our community.
- Key features:
 - o Expanded access to medical assessments and culturally appropriate trauma therapy for our children
 - o Collaboration and partnership with Washington County agencies, leaders, professionals, educators and our diverse community members
 - o 20,000+ square foot facility that brings together experts in medical treatment, trauma therapy, advocacy and prevention surrounding child abuse, neglect and domestic violence

CARES NORTHWEST

- CARES Northwest is the first children’s advocacy center established in Oregon. Accredited by the National Children’s Alliance, its mission is to stop child abuse and neglect through multidisciplinary prevention, medical evaluation, and ongoing treatment in partnership with the community.
- CARES Northwest features:
 - o Specialized medical treatment and evidence-based trauma therapy for all children, regardless of ability to pay
 - o Coordinated care in collaboration with community partners to minimize trauma
 - o Bilingual and culturally competent teams to meet the needs of the child and family
 - o Urgent medical appointments with child abuse experts to care for children within 24 hours
 - o 24/7 consultation by medical providers trained in child abuse medicine
 - o Child abuse prevention training in partnership with local school districts

WASHINGTON COUNTY FAMILY JUSTICE CENTER (FJC)

- The Family Justice Center of Washington County was established in 2018 to provide hope, safety and healing to families impacted by domestic violence.
- The FJC provides wrap-around services in one location to domestic violence victims in partnership with a diverse array of community groups, nonprofits and governmental agencies.
- The FJC features:
 - o Onsite resources for counseling, advocacy shelter options and remote court access restraining orders
 - o Family coaching and financial assistance
 - o Support finding housing, rental assistance and utility assistance
 - o Legal support and guidance through partnerships with legal aid organizations
 - o Onsite law enforcement support to assist with reporting crimes

On behalf of the Hillsboro School District, it is my pleasure to provide this letter of support for the proposed co-location of a westside CARES NW office with the Family Justice Center of Washington County in the soon-to-be-vacated Tanasbourne 911 Call Center.

As you know, Washington County does not currently have a dedicated facility for child abuse victims, and in each of the past two years, the CARES NW office in NE Portland treated more Washington County children than Multnomah County children. The need is there, and the solution is clear.

Sadly, the Hillsboro School District has many students each year who are evaluated at CARES NW. Having a westside option for these students would remove a significant barrier to them receiving needed services.

Washington County's 911 call center building, known as the Washington County Consolidated Communications Agency or "WCCCA," will be vacated in 2021 when WCCCA moves to a new location. Opening a new westside CARES NW office and combining it with the Family Justice Center makes sense, represents good financial stewardship of County resources, and will allow families that have experienced violence and trauma to receive the support they need at a single location.

As the CEO of Safety Compass, I oversee service delivery for advocacy services for sex-trafficking survivors in 3 counties, with a particular focus on Washington County as I coordinate our Trafficking Task Force here. In virtually all cases when victims are identified, the need for rapid access to multiple forms of support and safety seeking aides becomes vital the welfare of the individuals we serve. Consolidation and co-location of services for children and adults in high lethality situations, literally saves lives. Increasing proximity to services also reduces the impact of privilege on participants, as whether or not a family owns a car, to be able to drive from provider office to another provider office, no longer becomes one of the major deciding factors in whether or not services are accessed.

I strongly encourage you to make the WCCCA building available as a combined location for CARES Northwest and the Family Justice Center, not only to promote the health and safety of children and families today, but the well-being of Washington County for future generations.

I am pleased to support the request to make the Washington County Consolidated Communications Agency (WCCCA) building available as a combined location for the Family Justice Center and CARES Northwest after the Washington County 911 call center moves to their new location in 2021.

Washington County Kids is dedicated to optimizing the success of children in the county and that includes early intervention as well as the use of out of school time (early learning, afterschool, and summer- OST) programs to prevent child abuse problems. Families who have their children participate in OST programs are more likely to learn positive ways of dealing with problem behaviors. They also have the relief of knowing their children are safe while they are working. The adults are also able to obtain and keep jobs that add to their sense of self-worth and mitigate depression and economic problems that often precipitate abuse. Their children also have the influence of positive adults who model positive ways of dealing with conflict. In addition, program providers are usually considered "mandatory reporters" so they are required to report early signs of child abuse. Thus, we consider the OST programs and CARES NW personnel to be partners in prevention and early intervention.

Having toured the CARES NW facility in Portland and talked with their staff, I have become aware of the acute need for child abuse evaluation and treatment among Washington County residents. It is important to provide these services close to where residents live so they can avoid the long commute that might discourage them from obtaining and following through on care.

Dear Washington County Board of Commissioners:

The Family Justice Center of Washington County (FJCWC) Board of Directors is writing this letter requesting your support of the Washington County Consolidated Communications Agency (WCCCA) building as a future home for the FJCWC and Child Abuse Response and Evaluation Services (CARES) Northwest once the Washington County 911 Call Center moves to their new location.

In October 2003, President George W. Bush announced the creation of the President's Family Justice Center Initiative. This \$20 million Initiative created co-located, multi-disciplinary service centers for victims of family violence and their children. We are designed to reduce the number of places victims of domestic violence, sexual assault and elder abuse must go to receive needed services. Mary Beth Buchanan, Acting Director of Office on Violence Against Women stated "the Family Justice Center is, at its core, a concept that increases community capacity while also providing diverse, culturally competent services to victims and their children in a single location." The FJC model is identified as a best practice in the field of domestic violence intervention and prevention services.

The Family Justice Center of Washington County (a 501c3 organization) opened its doors in Beaverton in March of 2018. We have provided over 12,295 services to victims and survivors since that time and continue to work alongside 22 different agencies. We work closely with the Alliance for Hope International located in San Diego as well as Multnomah and Clackamas Family Justice Centers. Both of these Centers are supported by their respective county and housed in a county owned building. We understand developing and maintaining support from local government (cities and county), business, labor, diverse social service organizations, nonprofits and faith based organizations increases the resources available to victims and their children. Strong support from our elected officials also increases the effectiveness and sustainability of a center serving family violence and child abuse victims!



Strengthening our response to child and family trauma is critical to the well-being of Washington County communities. Since 1987, CARES Northwest has served Washington County children at their Northeast Portland location. In 2018, for the first time in 30 years, CARES Northwest served more Washington County children than Multnomah County children.

Washington County leaders and community members are working to bring CARES Northwest to a Washington County location shared with the Family Justice Center to establish a state-of-the art facility where families who experience any violence in the home can receive the needed support at one location.

Over a year ago, prior to my retirement in January 2020, I served as the Police Chief in Forest Grove where I had been part of a steering committee working to bring CARES Northwest to Washington County. Having seen too many investigations of child abuse and/or sexual abuse in our County, I really understood then, and certainly understand now, the importance of making this a reality for all those currently living in our great county. I also had the privilege of sitting on the initial steering committee that worked at bringing the Family Justice Center to our County and I had continued to stay involved with the FJC up until my recent retirement. I've come to understand that there is a possibility of having both CARES Northwest and the Family Justice Center possibly being able to co-locate in what is now the current WCCCA building. Knowing that WCCCA will be moving to their new location this next year, this seems like an amazing opportunity for our County to put two needed services together where all our residents can be cared for with the services that are so badly needed by many.

I'm such an advocate for the CARES Northwest first and foremost because I believe in their mission, but also because when I was 14 years old, I was a victim of rape and I just didn't know what to do as a kid. I never want a child to feel what I felt and to be too scared to tell someone. I always felt it was my fault and my abuser encouraged years of that thinking. I carried this secret for too many years and I still feel guilty for not speaking up when it happened. However, knowing what I do now and from my background in law enforcement, I know that our children need that opportunity to find people and resources to help them understand what happened and to be shown different possible coping mechanisms that might continue to help them as they grow into the life that they were meant to have. I also spent 18 years teaching Domestic Violence Response and Sexual Assault Investigation to recruit officers at a police training academy in North Carolina which has further given me the needed understanding on the critical importance in how Adverse Childhood Experiences increase the likelihood a child will

experience mental health problems, difficulty with school or employment, addiction, homelessness and/or criminal behavior over the course of their life.

Washington County leaders and community members have been working for the past year with the goal of bringing CARES Northwest to Washington County in a location shared with the Family Justice Center. This could be precedent setting in all the best ways possible for the people of our county, but more importantly, for our children who deserve the best possibility at a life that we might dream for them.

Since my retirement in January, I chose to continue my service to others by accepting a position as a Relationship Manager for the Center for Policing Equity, a national organization working with law enforcement agencies across the country to put an end to any disparate treatment that our communities of color might suffer from when engaging with law enforcement. Overall, I see life as our ability to continue to give back to others, especially those that have less than us. This is how I view the opportunity that sits in front of each of you, as our County Commissioners, regarding the possibility of co-locating the Family Justice Center with the amazing CARES Northwest organization. There could be no better service to the residents of Washington County and I strongly encourage you to move ahead on this concept as not only a way to promote the health and safety of children and families today, but the well-being of Washington County for future generations.



I am writing in support of making the Washington County Consolidated Communications Agency (WCCCA) building available as a combined location for the Family Justice Center and CARES Northwest (after the Washington County 911 call center moves to their new location in 2021).

CARES Northwest provides evaluation, medical treatment, crisis intervention, and therapy to children who have suffered physical or sexual abuse, neglect, or exposure to domestic violence. Experts estimate that as many as one in three girls and one in six boys may experience this type of abuse by the time they reach 18. Research on Adverse Child Experiences show how trauma in childhood can increase the likelihood a child will experience mental health problems, difficulty with school or employment, addiction, homelessness and/or criminal behavior over the course of their life. CARES Northwest is the only facility serving these children in Multnomah and Washington counties, and in each of the last two years, CARES has seen more children from Washington County than Multnomah.

Currently, Washington County children who are experiencing abuse must travel to North Portland to seek services from CARES Northwest. In response to this, Washington County leaders and community members have been working to bring CARES Northwest to Washington County in a location shared with the Family Justice Center. For more than a decade, I have had the honor to serve as a volunteer Victim Advocate working with the Child Abuse Team of the Washington County District Attorney's Office. Throughout that time, I have met literally hundreds of families working their way through the criminal prosecution portion of cases involving the neglect, physical mistreatment or sexual assault of children. By the time prosecution actively begins, it may have been a span of several months or, in cases with delayed disclosure, many years from the behaviors that resulted in criminal charges ultimately being filed.

All too often, the individuals I meet arrive at the criminal prosecution stage of their journey without any cogent plan to deal with past, present, or potential future behavioral issues. All too often, these families are overwhelmed and emotionally drained by a cycle of abuse and dysfunction. All too often, these families are unable or unwilling to recognize the long term damage hidden just below the surface of the entire family dynamic. All too often, a parent has shared with me that they too had experienced neglect, physical abuse or sexual assault as a child.

Any opportunity, ANY OPPORTUNITY AT ALL, to enhance the ability of professionals to intervene early in the chain of events that these families endure should be supported. Any opportunity to streamline, consolidate, or lighten the burden placed on traumatized families as they progress through the process — from reporting, to police investigation, to CARES Northwest, to assessment of services needed, to services provided, and ultimately to testimony at a public trial — should be supported.

I am aware that there is currently consideration being given to bringing together a Washington County satellite CARES Northwest location and the Family Justice Center in a County facility that presently houses the Washington County Call Center. To the extent that local access to the professionals at CARES Northwest can be combined with enhanced provision of ongoing support and follow-up services available through CARES and the Family Justice Center, the County as a whole will be well served now and into the future.

As both a volunteer Victim Advocate and a resident of Washington County, I strongly support a decision to dedicate the Washington County Consolidated Communications Agency building to this purpose when it is vacated in 2021.

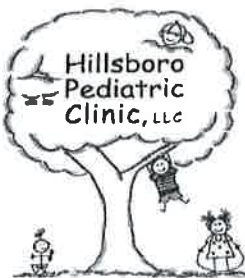



response time of community partners such as law enforcement agencies and Department of Human Services (DHS) caseworkers. As a social worker with CARES Northwest, I believe there are some families and situations that cannot afford to wait in the long commute. Opening the WCCCA building to CARES Northwest would provide that timely resource to Washington County children and families.

In addition to children being seen urgently at a Washington County location, children would also have access to ongoing specialized therapy services in their area. It has been my experience as a CARES Northwest social worker that some families do not engage in therapy services because there is not a local resource. Exposure to childhood trauma increases the likelihood a person will experience mental health problems, and difficulty with school, among other concerns as they age. Making the WCCCA building available to CARES Northwest would provide a resource for these families who are otherwise unable to address their children's trauma with adequate resources. With the therapies and supports CARES Northwest can provide, there are decreased chances for these children to have adverse experiences as they age as a result of their trauma.

We are similar in our missions and like CARES NW our mission is to provide a collaborative, community based program for domestic violence, where they are committed to assessment, treatment and prevention of child abuse in one location. Many of the characteristics of child abuse and domestic violence go hand in hand. Both agencies are alike in we both have one location for clients to get many of the needed services.

CARES NW is not only concerned about child abuse and neglect they are also concerned for children exposed to domestic violence. The statistics support what practitioners know – 30% to 60% of children living in homes with domestic violence are also victims of abuse (JL Edleson), Growing up in a home with domestic violence can be dangerous to children as well as they learn behaviors that follow them to adulthood, perpetuating the cycle domestic violence. Both domestic abuse and child abuse are centered around power and control.

We offer comprehensive services for domestic violence including: advocacy, safety planning, restraining orders, counseling, financial assistance, legal assistance, childcare and law enforcement. 

I would like to submit this letter to articulate my support of the request to utilize the former WCCCA building to house CARES NW and the Family Justice Center. I believe this would be an enormous asset to Washington County and the members of our community. During the 13 years I served as a victim's advocate for the Washington County District Attorney's Office, several of which I served as the Child Abuse Multi-Disciplinary Team Coordinator, I witnessed daily the impact that involvement in criminal investigations and prosecution had on victims and their families. They are typically under a tremendous amount of stress and hardship dealing with the aftermath of the crime, the time it takes to meet with various agencies and community service providers, and meeting the additional needs of their family. In the case of child abuse and domestic violence, there were often additional struggles when the offender is a family member and oftentimes a primary source of income and the remaining parent now has to provide sole financial support for their family.

I also routinely observed the positive impact CARES NW had in supporting these children and their families – we are so fortunate to have them as a resource. The collaboration between law enforcement and CARES NW to interview child victims and witnesses so as to minimize re-traumatization is essential and they provide outstanding emotional support and services to victims. However, unfortunately, it is often a great hardship for families to take time off work and school and get to the CARES NW location in Portland especially when they don't have a vehicle. CARES NW provides such an essential service to the children and families of our community and it would be an enormous asset to have a satellite office in Washington County that would make it easier for these families to access their services.

If Washington County could provide one place where families could go to participate in the forensic interviews, get assistance in filing protective orders, get therapeutic support, and other services needed, it would help remove some of the many hardships victims face in the aftermath of these crimes of family violence. My organization, Oregon Child Abuse Solutions, partners with local community experts to strengthen solutions for child abuse. CARES Northwest is one of our over 20 children's advocacy centers (CACs) that provide needed intervention, prevention, and therapeutic services for children who may have experienced abuse. For decades, Washington County children have traveled to Portland to receive services they should be guaranteed to receive locally. When a child has built up the courage to talk about difficult experiences, our communities should respond with services, help, and ongoing support like trauma-focused therapy.

Often times, travel can be a barrier to families receiving the services necessary for their healing and ongoing health and safety. Imagine a teenager who needs to balance school, a part-time job, and her needed therapy for abuse she suffered beyond her control. Now imagine her therapy is a 50 minute one-way bus ride away. 

I am writing in support of making the Washington County Consolidated Communications Agency (WCCCA) building available as a combined location for the Family Justice Center and CARES Northwest (after the Washington County 911 call center moves to their new location in 2021).

I have worked in the CARES Northwest Intake Department and our Prevention Department. In my opinion, we need a permanent home in Washington County for the following reasons:

1. Currently, families who live in Washington County spend at least 45-60 minutes commuting to/from their CAERS Northwest appointment. This time estimate is based on driving to our North Portland location. However, many of our families don't have access to a car and rely on public transportation. Therefore, they need to take a combination of 2-3 buses and MAX to get to the CARES Northwest office. This places undue stress on families who are already stressed due to concerns of child neglect and abuse.
2. We have a strong child abuse prevention program in Washington County. Our CARES Northwest comprehensive violence prevention curriculum is the official curriculum for the Beaverton and Hillsboro School Districts. Research shows that rates of disclosure increase after implementing violence prevention curriculum. Therefore, we expect more referrals to CARES Northwest. Additionally, our prevention staff have been training teachers and counselors in the Beaverton and Hillsboro District for years now. Because teaching youth about child sexual abuse prevention is new for many teachers, having a "home" in Washington County would help to collaborate more closely and enhance our ability to establish relationships with the other school districts in Washington County. Furthermore, for years now, CARES Northwest prevention staff have provided child abuse prevention to many pre-school centers in Multnomah County. Having a permanent site in Washington County would help us provide this service to pre-school and childcare centers in that county as well.

I hope this letter adds some different information to the types of statements of general support that you have received. Because of these reasons (and others), I strongly encourage you to make the WCCCA building available as a combined location for CARES Northwest and the Family Justice Center, not only to promote the health and safety of children and families today, but the well-being of Washington County for future generations.


As part of the supervisory team for Child Protective Services in Washington County, I understand the critical role CARES NW services to the children of our community as well as the importance of ongoing supportive services for children to work through the trauma they endure. To bring the services of CARES NW and the Family Justice Center to one location would be of immense assistance to the families we serve as well as the staff who assess child safety. While we have seen our referral numbers drop during the COVID 19 pandemic, Washington County has seen a roughly 50% increase in reports of child abuse in the last year and half. Many of these cases require a review by a designated medical provider, which is CARES NW for Washington County. Travel to and from Portland is time consuming for child abuse investigators and sometimes a barrier for a families whose children need that immediate medical attention. While CARES NW has opened up site in Beaverton, we often lack to the ability to coordinate timely and needed therapy for these children. To be able to provide this in one setting and within our county would provide more opportunity for Washington County families to get timely services and reduce the ongoing trauma associated with the victimization of child abuse. It would allow for Oregon Department of Human Services and our Law Enforcement

partners to team better by having a clinic close to where the work is done, which certainly adds to a reduction in trauma for those impacted by abuse and neglect.

I strongly encourage you to make the WCCCA building available as a combined location for CARES Northwest and the Family Justice Center, not only to promote the health and safety of children and families today, but the well-being of Washington County for future generations.

I don't need to tell you that those very potential results of childhood trauma are a checklist of the very serious problems that every community faces today. During my career I had a courtside view of the domestic violence and physical and sexual abuse of children that impacted families, children and our community. I heard and saw the trauma and pain. Almost daily we would see the aftermath of domestic violence and childhood trauma: persons being re-victimized, persons struggling with addiction and mental health problems, and persons

involved in all sorts of criminal activity. The research is accurate and plays out every day. An opportunity to improve our County response shouldn't be passed up.

In my career I believe that Washington County Board member have always recognized the horrible impact of domestic violence and child abuse on our community. The CAO office and the Board always provided resources and support for crime victims. My office consistently received resource to deal with child abuse and domestic violence. Multiple examples exist of County support for families and children affected by domestic violence. In recent years the County provided resources for Steve Berger's Community Corrections Department to supervise and work with convicted dv offenders when the State would provide no financial support. The Board has been critical and essential in supporting the Family Justice Centre in its opening and successful operation. Former Commissioner Malinowski was a constant presence in the planning, development and ultimate opening. Present Commissioners Schouten and Rogers were always strong supporters of County efforts to deal with domestic violence and crimes against children in our communities.
