Hello, my name is Cade Tiller and I am from Burns Oregon. I am a sophomore at Treasure Valley Community College with one more term to go until I receive my Associates of Science Transfer Degree in Wildlife Science. I am writing this testimony regarding my support for SB 5528.

I think community colleges are important for many people for many different reasons, and I am proud to say I attended a great community college that set me on the right path and was some of the best years of my life. Here are a couple reasons why I attended a community college. First, it was affordable. With a lot of family problems and medical bills I could not afford to go to a University, and I think a lot of kids are in the same boat I am. We need community colleges for people who cannot afford to go to a 4 year but are still wanting to get an excellent education. TVCC was also pretty local to me, only being 2 hours away from my home town which was nice for me because I am a big home body. But most of all, it had the exact right high level program I was wanting to go into. There are plenty of jobs in the workforce that I think a lot of kids don't know about today that are incredible opportunities to make money while also having a fun, but yet still a very important job. In the natural resource program here at TVCC we are learning how to manage and research these natural resources, and setting us on the right path to employment.
