Good morning Chair and members of the Committee,

This CHL law will, like all other gun control laws, disproportionately affect the poor, who will not only have trouble paying the higher fees associated with acquiring and maintaining a CHL but much more importantly, will not be able to afford legal representation when they unknowingly violate a municipality's CHL law. Then they will be on the hook for an insanely large fine, but let's be honest here, will likely just end up in jail.

I am a mother and as of this week, I will have my CHL. I have my CHL to protect myself and my daughter, and others, when we are out of the home. This new law would make it impossible to keep up on where and how I can carry. It seems intent on making us all felons. Should I be a felon because there is no possible way to keep abreast of every new ordinance for CHL carriers in all the different counties and cities in Oregon? Am I really worthy of PRISON when I drop someone off at the airport? Why can agents of the government have easy access to firearms for protection but not a young mother? If you vote yes on this bill, not only will you be effectively taking away my right to defend the life of me and my daughter, but you are saying you don't want poor people to have the same protection as those who can afford to fight for their rights in our broken legal system. Let it also not be lost on you, that the larger an area's minority population, the stricter their gun laws. How is this not seen as racist? How is it not seen as racist to expect by democrats about the protests could the left by their own logic even WANT minority populations or the poor to put their lives wholly and totally under corrupt police departments? I consider myself a feminist: how can women protect themselves from violent or aggressive men, who are clearly biologically stronger, without access to a handgun?

I am a very proud libertarian, registered with the Oregon Libertarian Party, and anti-war and violence to the core, and I am shaken to my very bones that the former director of the CIA, John Brennan, referred to libertarians as domestic terrorists after the events of January 6th.
