My name is Dori Wilkins and I am a patient of a Naturopathic Physician. I would like to share my experience working with an ND to show the importance and value of this profession in the state of Oregon.

First, I would like to say that I believe that naturopathic medicine is not recognized as it should be because of a lack of understanding or a level of ignorance on the subject. So please give me a few minutes to help educate you.

I have Hashimoto's Disease. This affects my thyroid. I have battled this condition for over 30 years. Many of the symptoms of Hashimoto's are as follows:

- Weight gain
- Fatigue
- Paleness or puffiness of the face
- Joint and muscle pain
- Constipation
- Inability to get warm
- Difficulty getting pregnant
- Hair loss or thinning, brittle hair
- Irregular or heavy menstrual periods
- Depression
- Slowed heart rate

For 28 of those years I went to several doctors, endocrinologists and specialists. None of those doctors and specialists did more than monitor and prescribe more medications, usually increasing or decreasing my one thyroid medication. As the years went on, I started feeling hopeless that anyone could help me. Then I decided to try a naturopathic doctor that many of my co-workers at Salem Health go to for their hormone and thyroid issues. She is the first person that took the time to investigate and treat my condition successfully. I have never had anyone figure out how to get my condition under control, except for her. For 2 years now, my thyroid has been successfully managed with a combination of pharmaceuticals and herbal medicine. I finally feel "normal". To not have to live with the systems of untreated Hashimoto's Disease is amazing! I wish I would have found Dr. Oberoi a very long time ago so that I would not have had to live the way I did for so many years.

For those of us with autoimmune issues, naturopathy is much more tuned in to the unusual and sometimes bizarre symptoms that we may present with. I suppose it was unfair of me to be disappointed with a PC's generic diagnosis of "contact dermatitis," as many of these symptoms are just beyond the expertise of conventional allopathic medical training. In my experience, I've found naturopaths to be way more skilled and impressive in their ability to read and coordinate blood test results, enabling them to diagnose underlying issues in a much more nuanced way, and often long before some issues may even show up visually as a problem. Naturopaths always give me more time than a standard 11-minute insurance visit, since I private pay. They unfortunately aren't valued by many insurance companies – and if they are, there are ridiculously low annual caps on their "benefit."

Naturopathic physicians identify and treat health issues through nutrition, vitamins/herbs/supplements, and numerous other alternative modalities which are certainly less toxic to the body than poisonous pharmaceutical drugs (with their pages of contraindications), and NDs assist the body to heal constitutionally. Their expertise is *complementary*, not competitive, since their approach is totally different than that of allopathic physicians. We need them both, and they should be valued and recompensed similarly.

I will *always* choose to try to resolve a health issue alternatively, and only avail myself of surgery or pharmaceutical drugs when I have no other option – and I'm grateful to have those options too, when they're needed. But it is certainly less expensive in the long run to address a health issue from a preventive nutritional approach, and it fosters overall health by addressing underlying causes instead of simply masking symptoms.

This took me 2 years and I finally found a doctor at OHSU that is able to see me and treat me 3 times a year. I am invoiced approximately \$20,000 for the 3 visits that take less than an hour each. The care is good but there is minimal connection to the rest of my wellbeing. I had no prior experience with naturopathic medicine.
