The Malheur County Court urges you to restore full funding to Oregon SBDC's. Our community relies on the Treasure Valley SBDC as a critical hub of economic and business development training, information, funding, liaison, and support. Throughout the pandemic, SBDC services have been more critical than ever in helping small business survive; its staff, programs and services are vital and irreplaceable. A reduction in services, forced by funding cuts, would have a devastating effect on our local businesses and economy.

Last year, the local TVCC SBDC met with nearly 400 clients to provide endless hours of business services, pandemic loan guidance, and assist in business startup.
