I left the practice of medicine to work for a private regulatory consulting group because insurance reimbursement was not adequate to cover the costs of living. I know of other colleagues that have had to decrease the amount of primary care patients they see and transitioned to out-of-pocket, procedure-based practices (such as aesthetic medicine) in order to make a living practicing medicine. I am asking you to vote yes on HB2673 to support fair pay for Oregon Naturopathic Physicians.

The disparity between reimbursements for Naturopathic Physicians on the one hand and MDs DOs, FNPs and PAs on the other has been succinctly described elsewhere (see "Commercial Health Insurance Reimbursements in Oregon Primary Care – Report on Years 2014-2016" by Jeff Clark, ND).

This disproportional discrepancy outlined by Dr. Clark must be corrected as it creates a business environment for Naturopathic Physicians that is untenable with success. Naturopathic medicine must be allowed to flourish as of all the professionals listed above, it is Naturopathic Doctors that are best trained to spare the State of Oregon unnecessary medical costs. Naturopathic Physicians are committed to following the tenet to "First Do No Harm". It is this principle that, when applied to patient care, provides the greatest benefit with the least potential for harm. This approach leads to improved outcomes and lower health care costs. For example, the underlying causes of conditions such as high cholesterol and diabetes are often poor diet and lifestyle factors such as lack of exercise. Changing these lifestyle factors can eliminate the need for one or more prescription medications that would typically be recommended for the rest of that patient's life.

According to the American College of Surgeons and the American Medical Association, among the most common surgeries performed in the United States are coronary artery bypass surgery, carotid endarterectomy, and low back pain surgery. Because NDs often promote less expensive, non-surgical options to patients earlier in the disease process, some of these expensive surgeries can be avoided. One major study investigating the effects of lifestyle improvement in patients with coronary atherosclerosis found that after only one year of following lifestyle recommendations, about 80% of participants were able to bring about plaque regression and avoid surgery without the use of lipid lowering agents. The study estimated that this would save almost \$30,000 per patient in the first year alone.

I am using these examples to substantiate the fact that Naturopathic Physicians hold a position of consequence in the Oregon health care system and that their businesses must be permitted to flourish. Insurance reimbursement for Oregon Naturopathic Doctors has quite simply made this success extremely unlikely. Dr. Clark has established that that the single most significant factor that has prevented the Oregon community of NDs from achieving even moderate financial fluidity is the current status of insurance reimbursements for Naturopathic Physicians.

Please correct this oversight, support the position that the Naturopathic community is best trained to save the State of Oregon millions of dollars of health care costs and vote in favor of HB2673.

Dear Oregon State House and Senate Health Care Committees,

I am a Naturopathic Physician (ND) working in Eugene, Oregon. I am writing to ask for your support of HB 2673, the Naturopathic Physician Pay Parity Bill. I am currently a primary care physician working in a Federally-Qualified Health Center, but I previously ran a private practice here in Eugene, and I am intimately familiar with the challenges that a lack of pay parity creates for the doctor working in solo or small-group practice.

If you're not aware, naturopathic physicians in Oregon are licensed as primary care providers, and our education is geared towards this. We treat chronic conditions, such as diabetes, hypertension, and chronic pain, as well as acute issues like Strep throat and urinary tract infections. We prescribe medication, refer to specialists, order labs and imaging, render diagnoses, and provide services such as Pap smears, immunizations, and health counseling.

Unfortunately, due to our small size as a profession, insurers have dramatically underpaid us for decades. I recall from private practice one insurer that would pay \$15 for a service that any other provider (MD, DO, or nurse practitioner) might receive \$100-200 for. Other insurers regularly paid 50-75% of what other practitioners would get for the same service. The Oregon Health Plan pays NDs comparably to other practitioner types – why can't private insurers?

This intentional underpayment of naturopathic physicians <u>for comparable service</u> creates several problems for both the doctors (almost all of them are local small business owners) and their patients. It makes it difficult to invest in additional equipment, or to hire support staff. It impacts patient choice, as many NDs choose not to contract with the most egregiously underpaying insurers. For many NDs, they move away from clinical practice entirely, choosing to work in the natural products industry rather than continue.

At a time when we have a severe primary care shortage, a massive pandemic, and an ongoing chronic pain/opiate problem, this bill is a significant step to help keep naturopathic physicians in the primary care workforce.

I am asking that you vote yes on the Naturopathic Physician Pay Parity bill. Thank you for your consideration of this.

We continue to care for our patients at times via telemedicine, and when needed, face to face in the office, even though it puts our own health at risk. We did this because this is the duty of a primary care provider. As that I have all of the responsibilities and risks of any other primary care provider, the great disparity in pay has become nearly untenable for me.

My name is Dr. Eliot Edwards and I am a Naturopathic Doctor and a Fellow of the American Board of Naturopathic Oncology (FABNO). My practice is focused on integrative oncology care, where I work collaboratively with my medical oncologist colleagues (MDs/DOs) to provide support for patients fighting cancer.

I would like to share my experience working in Oregon as a licensed ND delivering quality healthcare in my community, the barriers I face in delivering this care and ask you to please support HB2673. My patients rely on my care to help make their cancer treatments tolerable – minimizing common side effects and maintaining their quality of life, during otherwise incredibly challenging treatments.

One challenge for many patients, however, is the limited coverage many insurance policies provide for naturopathic physicians. Some of these plans limit reimbursement, specifically for naturopathic physicians, despite NDs being fully licensed and recognized physicians in the state of Oregon. This makes it more difficult for doctors like me to stay in practice and deliver this essential care for patients fighting cancer. In turn, it limits access to healthcare for many individuals and families when naturopathic doctors are forced to opt out of accepting these insurances who reimburse NDs significantly less than other doctors and mid-level providers (NPs, PAs). And for those of us who have been able to stay in practice, we do so at a great economic disadvantage to our peers, making it difficult to repay student loans, buy a house, raise a family and give back to the community.

My wife, daughter and I moved back to Oregon in 2017. My wife is also a naturopathic physician. We moved back here from Illinois largely because naturopathic physicians are fully licensed and highly integrated into the medical system in this state. Despite that recognition, discrimination in the form of poor reimbursement continues even here in Oregon through unfair practices by the insurance companies. Please help us change this issue.

Dear Senate and Health Care Committees,

I am asking you to vote yes on HB2673 to support fair pay for Oregon Naturopathic Physicians.

The disparity between reimbursements for Naturopathic Physicians on the one hand and MDs DOs, FNPs and PAs on the other has been succinctly described elsewhere (see "Commercial Health Insurance Reimbursements in Oregon Primary Care – Report on Years 2014-2016" by Jeff Clark, ND).¹

This disproportional discrepancy outlined by Dr. Clark must be corrected as it creates a business environment for Naturopathic Physicians that is untenable with success. Naturopathic medicine must be allowed to flourish as of all the professionals listed above, it is Naturopathic Doctors that are best trained to spare the State of Oregon unnecessary medical costs. Naturopathic Physicians are committed to following the tenet to "First Do No Harm". It is this principle that, when applied to patient care, provides the greatest benefit with the least potential for harm. This approach leads to improved outcomes and lower health care costs. For example, the underlying causes of conditions such as high cholesterol and diabetes are often poor diet and lifestyle factors such as lack of exercise. Changing these lifestyle factors can eliminate the need for one or more prescription medications that would typically be recommended for the rest of that patient's life.

According to the American College of Surgeons and the American Medical Association, among the most common surgeries performed in the United States are coronary artery bypass surgery, carotid endarterectomy, and low back pain surgery. Because NDs often promote less expensive, non-surgical options to patients earlier in the disease process, some of these expensive surgeries can be avoided. One major study investigating the effects of lifestyle improvement in patients with coronary atherosclerosis found that after only one year of following lifestyle recommendations, about 80% of participants were able to bring about plaque regression and avoid surgery without the use of lipid lowering agents. The study estimated that this would save almost \$30,000 per patient in the first year alone.

I am using these examples to substantiate the fact that Naturopathic Physicians hold a position of consequence in the Oregon health care system and that their businesses must be permitted to flourish. Insurance reimbursement for Oregon Naturopathic Doctors has quite simply made this success extremely unlikely. Dr. Clark has established that that the single most significant factor that has prevented the Oregon community of NDs from achieving even moderate financial fluidity is the current status of insurance reimbursements for Naturopathic Physicians.

Please correct this oversight, support the position that the Naturopathic community is best trained to save the State of Oregon millions of dollars of health care costs and vote in favor of HB2673.
