## Re: I SUPPORT [SB 5531]... LUBA protects and defends Oregon's Resource Economy!

I have reviewed Governor Brown's lack luster and incompetent budget allocations to LUBA for 2021-2023.

Despite a slight increase in LUBA's budget, it is not enough for LUBA to adequately adjudicate the increase in case loads the legislation listed below will create.
