

## Congressional Plan

**This document lists how the Congressional Plan complies with the requirements in ORS 188.010.** The ‘integrity test’ on the ESRI Redistricting application screens all submissions to ensure that each plan adequately complies with the Oregon’s requirements for contiguity and equal population in redistricting plans. The Congressional Plan passed the integrity test and was successfully submitted through the ESRI application. This document describes the transportation links as well as the existing and geographic and political boundaries that the Congressional Plan uses to avoid dividing communities of common interest.
