SB 891

Extends suspension of termination of residential tenancies for nonpayment of rent for tenants who have applied for emergency rental assistance and provided documentation of application to their landlord on or before June 30, 2022, throughout period that application is pending.

SB 892

Directs State Department of Agriculture to establish forgivable loan program to provide financial assistance to farming and ranching producers in Oregon with lost gross farm income in calendar year 2021 due to qualifying natural disaster.

SB 893

Requires prioritizing financial assistance to local law enforcement agencies to partner with community-based organizations in order to address humanitarian crisis associated with unlawful marijuana cultivation or distribution operations in awarding grants through Illegal Marijuana Market Enforcement Grant Program.
