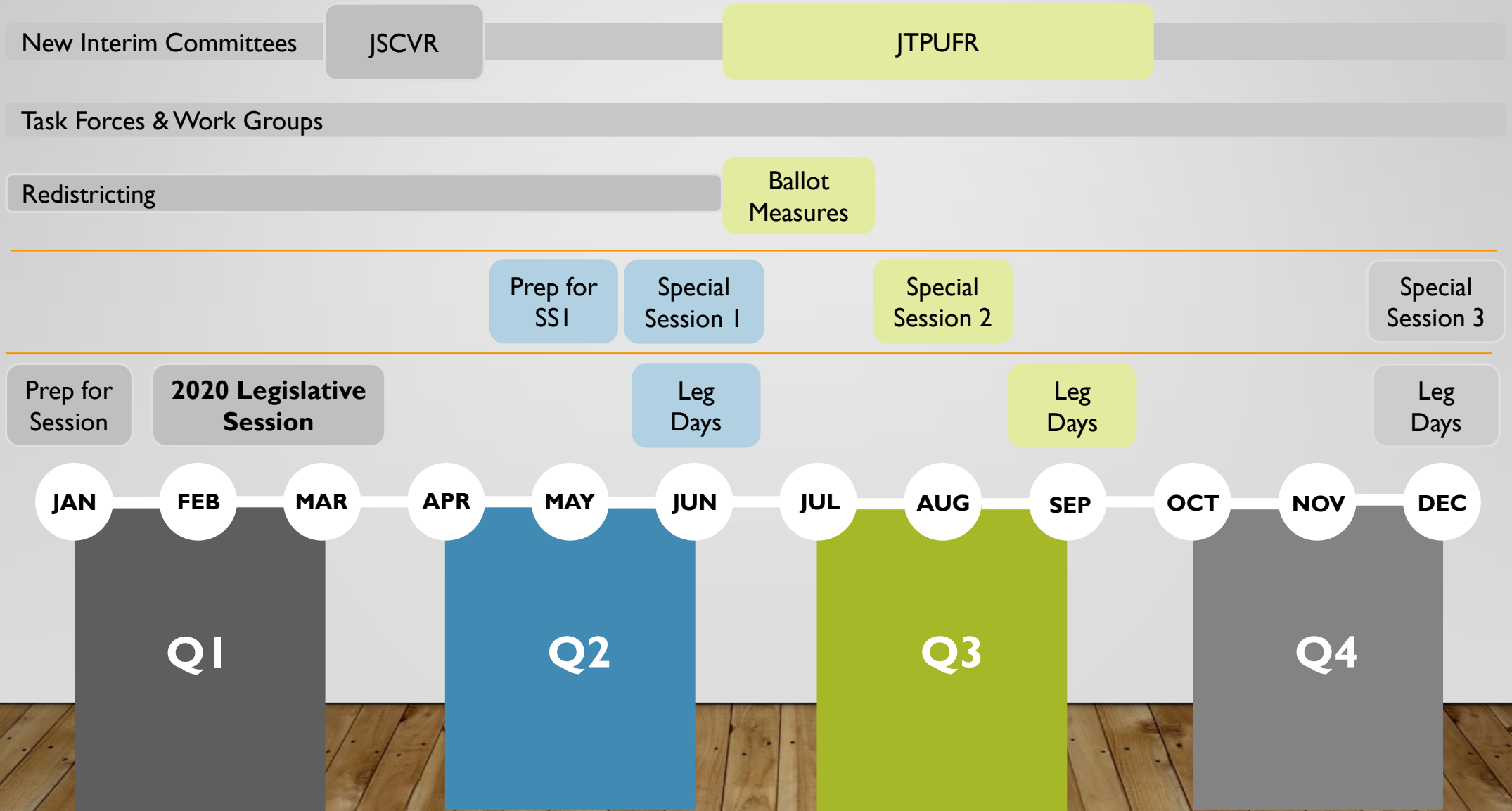

## Gradually Built Up Remote Process

- Started with hybrid – some participants in person, some remote
- All-remote informational meetings
- Remote meetings with live public testimony



# 2021 Legislative Session

- Oregon Legislative Information System (OLIS): search by topic, bill, committee, legislator
    - Great way to find out if a bill exists
    - E-Subscribe on bill page, committee page, at the bottom of any page for email updates
  - When your bill is scheduled for a public hearing...
    - Sign up to testify until scheduled start time of the meeting
    - Provide written testimony up to 24 hours after the scheduled start time of the meeting

# Day of the Meeting

- Call in/log into the meeting on mute with camera off
- When your name is called, unmute and turn on your camera (optional)
- Provide your testimony, any Q&A with committee members
- Once done testifying, turn off camera and mute
- If few people in the meeting, may stay and listen
- If many people in the meeting/waiting to testify, committee staff may exit you to watch the meeting on OLIS stream

Please submit written testimony using the form below. Written testimony may only be submitted for bills that are scheduled for a public hearing. Testimony must be received within 24 hours after the start time of the committee meeting at which the public hearing is held. (Example: If a bill is scheduled for a public hearing at a committee meeting that starts at 3 pm on February 10th, testimony must be submitted before 3 pm on February 11th.) All testimony will be displayed publicly, so please DO NOT include personal information that you do not want available to the public. Your name and the organization you represent or the city in which you live will appear online alongside your testimony. The email address you use to submit your testimony will not be publicly displayed. All submitted testimony will be posted on the Oregon Legislative Information System website.
