**PROPOSED AMENDMENTS TO
SENATE BILL 755**

1 On page 1 of the printed bill, line 2, delete “and”.

2 In line 4, before the period insert “; and declaring an emergency”.

3 On page 10, after line 2, insert:

4 **“SECTION 12a. Section 12b of this 2021 Act is added to and made a**
5 **part of ORS chapter 153.**

6 **“SECTION 12b. (1) An enforcement officer issuing a citation for a**
7 **Class E violation shall provide the person receiving the citation with**
8 **information concerning how the person may complete a health as-**
9 **essment, as specified in section 2 (2)(c)(B), chapter 2, Oregon Laws**
10 **2021 (Ballot Measure 110 (2020)), in lieu of paying a fine.**

11 **“(2) The requirement described in subsection (1) of this section may**
12 **be satisfied by providing the person with the telephone number for the**
13 **temporary telephone Addiction Recovery Center established under**
14 **section 23, chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)).**

15 **“SECTION 12c. Section 12b of this 2021 Act is amended to read:**

16 **“Sec. 12b. (1) An enforcement officer issuing a citation for a Class E vi-**
17 **olation shall provide the person receiving the citation with information**
18 **concerning how the person may complete a health assessment, as specified**
19 **in section 2 (2)(c)(B), chapter 2, Oregon Laws 2021 (Ballot Measure 110**
20 **(2020)), in lieu of paying a fine.**

21 **“(2) The requirement described in subsection (1) of this section may be**

1 satisfied by providing the person with the telephone number for the [*tempo-*
2 *rary telephone*] Addiction Recovery Center established under section [23] **2**,
3 chapter 2, Oregon Laws 2021 (Ballot Measure 110 (2020)), **in the coordi-**
4 **nated care organization service area where the person resides.”.**

5 On page 16, after line 28, insert:

6 **“SECTION 25a. The amendments to section 12b of this 2021 Act by**
7 **section 12c of this 2021 Act become operative October 1, 2021.”.**

8 After line 34, insert:

“EMERGENCY CLAUSE

12 **“SECTION 27. This 2021 Act being necessary for the immediate**
13 **preservation of the public peace, health and safety, an emergency is**
14 **declared to exist, and this 2021 Act takes effect on its passage.”.**
