### HB 4071

(8:30 am) Modifies description of persons eligible for targeted financial incentives in field of behavioral health.

### HB 4098

(8:50 am) Expands designated state agencies that must work with Alcohol and Drug Policy Commission and requires agencies to meet with commission quarterly to review and report on each agency's progress and to report process and outcome measures established under commission's comprehensive addiction, prevention, treatment and recovery plan.

### HB 4070

(9:10 am) Modifies charge to and member appointment process for Consumer Advisory Council that assists and advises Director of Oregon Health Authority on mental health, addiction and substance use disorder services.
