#### **Public Hearing**

HB 4086

(1:00 PM) Amends provisions of workers' compensation law related to beneficiaries.

HB 4106

(1:15 PM) Allows person employed by health care facility to practice surgical technology if person is enrolled in or has completed specified apprenticeship program or obtained specified certification.

HB 4152

(1:45 PM) Requires parties to franchise agreement to deal in good faith and commercially reasonable manner, and specifies required disclosures in franchise sale transaction.

HB 4126

(2:15 PM) Imposes requirements for accepting bids and proposals for contracts for provision and delivery of publicly financed behavioral health or addiction treatment or services.

Requires business entity that collects, stores or transfers personal data of resident individual to register with Department of Consumer and Business Services as data broker.

- A public access kiosk is at the Capitol Building for anyone without access to a phone or computer to join a meeting by video.
- Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.
- Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
