HB 4017 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires business entity that collects, stores or transfers personal data of resident individual to register with Department of Consumer and Business Services as data broker.

HB 4113

Adds to cancers covered by rebuttable presumption of occupational disease for eligible nonvolunteer firefighters.

HB 4086

Amends provisions of workers' compensation law related to beneficiaries.

HB 4106

Allows person employed by health care facility to practice surgical technology if person is enrolled in or has completed specified apprenticeship program or obtained specified certification.

### **Public Hearing**

HB 4138

(1:30 PM) Amends provisions of workers' compensation law related to payments of benefits, notice to workers, recovery of overpayments and errors in claims processing.

HB 4020

(1:45 PM) Requires certain residential general contractors proposing remodel or repair project of more than \$20,000 in value to tour residential structure with property owner and provide property owner with itemized and detailed description for each feature of proposed construction work.

HB 4103

(2:15 PM) Increases penalty for offenses related to engaging in professional real estate activity without holding active license.

  - **Register by phone:** 833-588-4500 (U.S. toll free). You will be given a phone number to call into the meeting.
- Registration closes one hour before the meeting is scheduled to begin.
- A public access kiosk is at the Capitol Building for anyone without access to a phone or computer to join a meeting by video.
- Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.
- Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
