- HB 4077 \*\* \*\*Subsequent Referral(s) to Ways and Means  
(1:00 pm) Renames Environmental Justice Task Force as Environmental Justice Council.
- HB 4148 \*\* \*\*Subsequent Referral(s) to Ways and Means  
(1:20 pm) Directs Department of State Lands, in consultation with State Department of Fish and Wildlife, to establish salmon credit program to encourage voluntary restoration of salmonid habitat and allow persons to meet compensatory mitigation obligations.

#### Work Session

- HB 4072  
(1:40 pm) Allows State Fish and Wildlife Commission to charge fees for hunting, angling and shellfish licenses, tags and permits that are less than amount established in statutory fee schedule.
