(4:05 - 4:30 pm) Expands crime of assault in the third degree to include causing physical injury to person working in hospital while worker is performing official duties.

HB 4008

Directs Oregon Criminal Justice Commission to study effect of payment of restitution on rates of recidivism, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2022.

HB 4007

Directs State Court Administrator to study issues facing court system and report on results of study to appropriate committee or interim committee of Legislative Assembly no later than September 15, 2023.

HB 4009

Directs Oregon Criminal Justice Commission to study effect of different types of sentences on rates of recidivism, and to provide results of study to interim committees of Legislative Assembly no later than December 31, 2022.
