HB 4131

(8:05 pm) Modifies provisions relating to use by law enforcement agencies of certain crowd control measures.

SB 1527 A

HJR 205

(8:50 am) Proposes amendment to Oregon Constitution to specify that section restricting certain banks does not prohibit establishment of bank owned or operated by State of Oregon.
