SB 1560 A

(8:05 am) Updates statutory references to individual who is not citizen or national of United States to replace "alien" with "noncitizen." Directs state agencies to use "noncitizen" in rules and regulations to reference individual who is not citizen or national of United States and to update rules and regulations that use "alien" to use "noncitizen." Authorizes agencies to amend rule without prior notice or hearing for purpose of changing term or phrase in order to conform with change made by law.

SB 1527 A

(8:30 am) Corrects statutory reference from "return identification envelope" to "secrecy envelope." Allows Secretary of State to send recount notice by electronic mail.

HJR 205

(8:55 am) Proposes amendment to Oregon Constitution to specify that section restricting certain banks does not prohibit establishment of bank owned or operated by State of Oregon.

HB 4050

(8:20 am) Directs Department of Public Safety Standards and Training to study issues relating to public safety and report on results of study to appropriate committee or interim committee of Legislative Assembly no later than September 15, 2023.
