Public Hearing

SB 1539

Establishes pilot program to provide funding to school districts for purposes of increasing access to schools by homeless students and improving academic achievement of homeless students.

SB 1572

Requires institutions of higher education in Oregon to adopt specified policies to combat sexual harassment, dating violence, domestic violence, sexual assault or stalking.

Public Hearing and Possible Work Session

SB 1521

Authorizes district school board to terminate superintendent without cause only if certain conditions are met.

SB 1522

Authorizes high school teachers who are employed by education service districts to serve as members of Transfer Council.

Register to testify live remotely:

- Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
