Establishes product stewardship program for mattresses.

- SB 1518  
Adds Reach Code to state building code as specialty code and gives power of administration and interpretation of Reach Code to Director of Department of Consumer and Business Services.
- SB 1567  
Requires owners or operators of bulk oils and liquid fuels terminals to conduct and submit to Department of Environmental Quality seismic vulnerability assessments.
