### HB 4005 -1, -2 STAFF MEASURE SUMMARY

#### WHAT THE MEASURE DOES:

Enacts the following:

- extends by one year the date by which the Early Learning Council is required to establish a process for determining the true cost of child care to July 1, 2023;
- clarifies the role of the Office of Child Care in relation to the resource and referral system;
- extends by 15 months the date by which the Early Learning Division must report on the implementation of the suspension and expulsion ban;
- modifies provisions governing the Office of Child Care's ability to share information;
- modifies provisions governing the Employment Related Day Care (ERDC) subsidy program, including
  establishing a definition of subsidized care facilities and requiring subsidized care facilities to participate in the
  central background registry, allows the Early Learning Council to remove individuals from the Central
  Background Registry for violating certain rules and allows the Department of Human Services, the Office of
  Child Care, and the Early Learning Council to take any actions necessary to provide for ERDC's transition from
  DHS to DELC;
- allows the use of Early Learning Account moneys for costs incurred in conducting the required biennial evaluation;
- requires the adoption of ERDC reimbursement rates that are equal to or greater than the 90th percentile of
  the 2020 Oregon Child Care Market Price Study rate for certified or registered providers, 85 percent of that
  amount for exempt child care centers that are enhanced, 75 percent of that amount for exempt child care
  centers that are not enhanced, and an 18 percent increase over the maximum rates on January 1, 2022 for
  exempt family child care homes; and
- postpones the date on which automatic sprinkler systems may be required for child care facilities to January 1, 2024 and establishes a related reporting requirement.

#### **EFFECT OF AMENDMENT:**

- -1 Modifies a reporting date related to Employment Related Day Care costs, modifies definitions of subsidized care and subsidized care facility, allows for gradual transition of Central Background Registry from Department of Human Services to Early Learning Division, removes provisions relating to sprinklers, and makes technical changes.
- -2 Modifies a reporting date related to Employment Related Day Care costs, modifies definitions of subsidized care and subsidized care facility, requires subject individuals to be enrolled in Central Background Registry, allows for gradual transition of Central Background Registry from Department of Human Services to Early Learning Division, removes provisions relating to sprinklers, and makes technical changes.
