Measure Description:

Modifies provisions of tax laws. Eliminates expansion of the rural medical provider tax credit. Extends the Gain Share sunset extension. Allows eligible personal income or corporate income taxpayer to elect to use a three-year net operating loss carryback. Makes changes to the net operating loss carryback applicable to tax years 2023 through 2028, but only if House Bill 4002 (2022) becomes law before January 1, 2023.
