## **Measure Description:**

Establishes the Task Force on Victim Access to Police Records.

## **Government Unit(s) Affected:**

Legislative Policy and Research Office (LPRO), Counties, Oregon State Police (OSP), Cities, Oregon Judicial Department (OJD), District Attorneys and their Deputies (DAs), Department of Justice (DOJ), Public Defense Services Commission (PDSC), Legislative Assembly, Department of Human Services (DHS)

# **Summary of Fiscal Impact:**

Costs related to the measure may require budgetary action - See analysis.

#### **Analysis:**

This measure establishes the 14-member Task Force on Victim Access to Police Records, specifics membership requirements, and task force duties. The task force is charged with developing recommendations for legislation to ensure victims of crime, abuse, neglect, or other potentially criminal conduct can access law enforcement entities records related to the crime that was perpetrated against them. This measure directs the Legislative Policy and Research Director to provide staff support and requires the task force to submit a report and recommendations to the Legislative Assembly by November 1, 2022. This measure repeals the task force on June 30, 2023 and declares an emergency effective on passage.

### Legislative Policy and Research Office:

The Legislative Policy and Research Office (LPRO) estimates this measure will have a fiscal impact of \$21,000 General Fund for the 2021-23 biennium for the cost of per diem and travel reimbursement for the 12 non-legislative members. Meetings are set by the chairperson and a majority of voting Task Force members; however, the estimated cost assumes members will participate in monthly meetings from March 2022 through June 2023. The 2021-23 LPRO budget includes resources to support legislative committees, workgroups, and task forces. LPRO anticipates that staffing the task force will be absorbed within current resources; however, depending on the total committees and task forces created, there is the potential for an accumulated fiscal impact.

### **Legislative Assembly:**

The Legislative Assembly estimates this measure will have a minimal impact. Two members of the Task Force will be legislative members who are entitled to per diem and travel reimbursement. Currently, resources are budgeted for members of the Legislative Assembly to participate in interim committees, boards, and task forces. However, if the work required by this Task Force or the cumulative enactment of other legislation with interim committees, boards, and task forces exceeds expenditure levels beyond those assumed in the 2021-23 budget, additional General Fund resources may be required.

The Oregon Judicial Department estimates a minimal fiscal impact and there is no fiscal impact for the Department of Human Services, Department of Justice, Department of State Police, District Attorneys, cities and counties.
