Summary of Revenue Changes

The Oregon State Board of Nursing (OSBN) collects applicant and renewal licensing fees from nursing professionals. House Bill 4003 directs OSBN to issue a nurse internship license to a qualified applicant, as long as the individual is enrolled in a nursing program and pays a license fee. It is unknown how many student nurses will seek a nurse internship license.

Summary of Human Services Subcommittee Action

HB 4003 increases OSBN's Other Funds expenditure limitation by \$500,000, on a one-time basis, in the 2021-23 biennium to support a wellness program for Oregon healthcare professionals. The measure directs OSBN to support an Oregon non-profit organization that promotes the wellness of health professionals through education, coordinated regional counseling, telemedicine services and research. In addition, HB 4003 directs OSBN to issue nurse internship licenses to qualified applicants, as long as the individual is enrolled in a nursing program and pays a license fee. OSBN has sufficient staffing capacity to administer the nurse internship program without incurring additional staffing costs.
