

# House Bill 4032

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Early Childhood for Representative Karin Power)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Directs Early Learning Division to develop and maintain informational resources relevant for children with disability. Requires child care providers and early childhood educators to receive training related to informational resources.

## A BILL FOR AN ACT

2 Relating to informational resources relevant for children with a disability; creating new provisions;  
3 and amending sections 64 and 68, chapter 631, Oregon Laws 2021.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Section 2 of this 2022 Act is added to and made a part of ORS 329A.250 to**  
6 **329A.450.**

7 **SECTION 2. (1) As used in this section, "child with a disability" means a child with a**  
8 **disability who is 17 years of age or younger.**

9 **(2) The Early Learning Division shall develop and maintain informational resources that**  
10 **are relevant for a child with a disability. Informational resources must be prepared for child**  
11 **care providers and early childhood educators and for parents or guardians of a child with a**  
12 **disability.**

13 **(3) Informational resources provided for child care providers and early childhood educa-**  
14 **tors under this section must include information about nonschool programs and services**  
15 **that are available for a child with a disability.**

16 **(4) Informational resources provided for parents or guardians of a child with a disability**  
17 **under this section must include:**

18 **(a) Information about nonschool programs and services that are available for a child with**  
19 **a disability;**

20 **(b) A description of the rights and protections provided to a child under the Americans**  
21 **with Disabilities Act, the public accommodation laws of this state, the Individuals with Dis-**  
22 **abilities Education Act and any other federal or state laws related to access to child care**  
23 **and education for children with a disability;**

24 **(c) A description of the processes and contact information for enforcing the rights and**  
25 **protections described in paragraph (b) of this subsection; and**

26 **(d) Any other information identified by the division that may be relevant for parents or**  
27 **guardians of children with a disability.**

28 **(5) The division must ensure that informational resources described in subsections (3)**  
29 **and (4) of this section are made available:**

30 **(a) In a concise, physical format;**

1 (b) In an electronic format; and

2 (c) In languages most commonly spoken and written in this state, as identified by the  
3 Early Learning Council by rule.

4 (6) The division shall consult with the State Interagency Coordinating Council, the Bu-  
5 reau of Labor and Industries, the Oregon Health Authority, the Department of Education,  
6 the Department of Human Services and any other relevant state agencies for the purposes  
7 of:

8 (a) Developing and maintaining the informational resources required under this section;  
9 and

10 (b) Identifying methods and processes for ensuring that parents and guardians of a child  
11 with a disability can easily access the informational resources when requested.

12 (7) The division shall consult with the Oregon Medical Board, the Oregon State Board of  
13 Nursing, the Oregon Board of Naturopathic Medicine and any other state boards identified  
14 by the Early Learning Council to ensure that informational resources described in subsection  
15 (4) of this section are provided to parents and guardians of children with a disability when  
16 either of the following occur:

17 (a) A child is diagnosed with a medical condition that may qualify the child for nonschool  
18 programs or services for children with a disability or that may qualify the child for pro-  
19 tections under federal and state laws described in subsection (4)(b) of this section; or

20 (b) A parent or guardian of a child with a disability requests informational resources.

21 (8)(a) The council shall adopt by rule requirements to ensure that child care providers  
22 and early childhood educators receive training related to the informational resources devel-  
23 oped and maintained under this section, including training on:

24 (A) Nonschool programs and services that are available for a child with a disability and  
25 how best to advise parents and guardians about how to access the programs and services;  
26 and

27 (B) The responsibilities of child care providers and early childhood educators to comply  
28 with federal and state laws described in subsection (4)(b) of this section.

29 (b) Training required under this subsection must be received:

30 (A) At the time of initial certification, registration, recording or licensure; and

31 (B) Periodically, as determined by the council by rule.

32 (c) Training required under this subsection shall be developed and periodically revised by  
33 the division after any necessary consultation with the state agencies identified in subsection  
34 (6) of this section.

35 (9) The Early Learning Council shall adopt any rules necessary for the administration  
36 of this section.

37 **SECTION 3.** Section 2 of this 2022 Act is amended to read:

38 **Sec. 2.** (1) As used in this section, "child with a disability" means a child with a disability who  
39 is 17 years of age or younger.

40 (2) The [*Early Learning Division*] **Department of Early Learning and Care** shall develop and  
41 maintain informational resources that are relevant for a child with a disability. Informational re-  
42 sources must be prepared for child care providers and early childhood educators and for parents or  
43 guardians of a child with a disability.

44 (3)(a) Informational resources provided for child care providers and early childhood educators  
45 under this section must include information about nonschool programs and services that are avail-

1 able for a child with a disability.

2 (4) Informational resources provided for parents or guardians of a child with a disability under  
3 this section must include:

4 (a) Information about nonschool programs and services that are available for a child with a  
5 disability;

6 (b) A description of the rights and protections provided to a child under the Americans with  
7 Disabilities Act, the public accommodations laws of this state, the Individuals with Disabilities Ed-  
8 ucation Act and any other federal or state laws related to access to child care and education for  
9 children with a disability;

10 (c) A description of the processes and contact information for enforcing the rights and pro-  
11 tections described in paragraph (b) of this subsection; and

12 (d) Any other information identified by the [division] **department** that may be relevant for  
13 parents or guardians of children with a disability.

14 (5) The [division] **department** must ensure that informational resources described in subsections  
15 (3) and (4) of this section are made available:

16 (a) In a concise, physical format;

17 (b) In an electronic format; and

18 (c) In languages most commonly spoken and written in this state, as identified by the Early  
19 Learning Council by rule.

20 (6) The [division] **department** shall consult with the State Interagency Coordinating Council,

33 federal and state laws described in subsection (4)(b) of this section; or

34 (b) A parent or guardian of a child with a disability requests informational resources.

35 (8)(a) The council shall adopt by rule requirements to ensure that child care providers and early  
36 childhood educators receive training related to the informational resources developed and main-  
37 tained under this section, including training on:

38 (A) Nonschool programs and services that are available for a child with a disability and how  
39 best to advise parents and guardians about how to access the programs and services; and

40 (B) The responsibilities of child care providers and early childhood educators to comply with  
41 federal and state laws described in subsection (4)(b) of this section.

42 (b) Training required under this subsection must be received:

43 (A) At the time of initial certification, registration, recording or licensure; and

44 (B) Periodically, as determined by the council by rule.

45 (c) Training required under this subsection shall be developed and periodically revised by the

1 *[division]* **department** after any necessary consultation with the state agencies identified in sub-  
 2 section (6) of this section.

3 (9) The Early Learning Council shall adopt any rules necessary for the administration of this

 18 Care to exercise, on and after the operative date set forth in subsection (1) of this section, all of the  
 19 duties, functions and powers conferred on the Department of Early Learning and Care by *[sections*

27 (3) For the purpose of ensuring that the Department of Early Learning and Care may exercise,  
 28 on and after the operative date set forth in subsection (1) of this section, all of the duties, functions  
 29 and powers conferred on the Department of Early Learning and Care by *[sections 12 and 13 of this*  
 30 *2021 Act]* **ORS 326.432 and 329A.750**, and the amendments to ORS 131A.360, 131A.365, 183.459,  
 31 279A.050, 326.425, 326.430, 326.435, 327.269, 327.274, 329.155, 329.156, 329.165, 329.170, 329.172,  
 32 329.175, 329.181, 329.183, 329.185, 329.195, 329.200, 329.219, 329.841, 329.843, 329.845, 329A.010,

 38 seamless transfer of duties, functions and powers.

39 (4) The Governor shall resolve any disputes related to the plan developed and implemented un-  
 40 der subsection (3) of this section, and the Governor's decision is final.

8 Early Learning and Care may undertake the collection or enforcement of any such liability, duty  
9 or obligation.

10 (2) The rights and obligations of the Early Learning Division or the Department of Education  
11 on behalf of the Early Learning Division legally incurred under contracts, leases and business  
12 transactions executed, entered into or begun before the operative date of the amendments to ORS  
13 326.430 by section 11 [*of this 2021 Act*], **chapter 631, Oregon Laws 2021**, are transferred to the  
14 Department of Early Learning and Care. For the purpose of succession to these rights and obli-  
15 gations, the Department of Early Learning and Care is a continuation of the Early Learning Divi-  
16 sion and not a new authority.
