

HOUSE AMENDMENTS TO HOUSE BILL 4074

By COMMITTEE ON ECONOMIC RECOVERY AND PROSPERITY

1 On page 1 of the printed bill, line 3, delete “section 13,” and insert “sections 13, 14 and 16,” and
2 after the semicolon insert “repealing sections 17 and 26, chapter 103, Oregon Laws 2018;”.

3 On page 3, delete lines 43 through 45 and insert:

4 “**SECTION 10.** Section 16, chapter 103, Oregon Laws 2018, as amended by section 39, chapter
5 542, Oregon Laws 2021, is amended to read:

6 “**Sec. 16.** [(1)] Notwithstanding ORS [475B.759] **475C.726**, before making any other distribution
7 from the Oregon Marijuana Account established under ORS [475B.759] **475C.726**, the Department of
8 Revenue shall first distribute quarterly from the account the following:

9 “[*a*] (1) \$875,000 to the Oregon Liquor and Cannabis Commission for deposit in the Marijuana
10 Control and Regulation Fund established under ORS [475B.296] **475C.297**; and

11 “[*b*] (2) \$750,000 to the Oregon Criminal Justice Commission for deposit into the Illegal
12 Marijuana Market Enforcement Grant Program Fund established under section 15, chapter 103,
13 Oregon Laws 2018, for the purposes of paying the costs incurred by the commission in carrying out
14 the provisions of section 13, chapter 103, Oregon Laws 2018.

15 “[*2*] *The final distribution made under subsection (1) of this section shall be made in the fiscal*
16 *quarter beginning on October 1, 2023.*]

17 “**SECTION 11.** Section 14, chapter 103, Oregon Laws 2018, is amended to read:

18 “**Sec. 14.** (1) [*Not later than January 1, 2020, and*] Not later than January 1 **of** each year
19 [*thereafter*], the Oregon Criminal Justice Commission shall submit a report in the manner provided
20 in ORS 192.245 on the status and effectiveness of the Illegal Marijuana Market Enforcement Grant
21 Program established under section 13 [*of this 2018 Act*], **chapter 103, Oregon Laws 2018**, to the
22 interim committees of the Legislative Assembly related to the judiciary.

23 “(2) **Not later than January 1 of each year, the commission shall submit a report in the**
24 **manner provided in ORS 192.245 on recommendations for changes to the funding of the Ille-**
25 **gal Marijuana Market Enforcement Grant Program to the interim committees of the Legis-**
26 **lative Assembly related to the judiciary. In making the recommendations described in this**
27 **subsection, the commission shall consider the best available information and projections re-**
28 **garding unlawful marijuana cultivation and distribution operations in this state and any hu-**
29 **man trafficking related to those operations.**

30 “**SECTION 12.** Sections 17 and 26, chapter 103, Oregon Laws 2018, are repealed.

31 “**SECTION 13.** There is appropriated to the _____, for the biennium ending June
32 **30, 2023, out of the General Fund, the amount of \$_____ for financial assistance to**
33 **community-based organizations that are responding to the humanitarian crises associated**
34 **with unlawful marijuana cultivation and distribution operations.”.**
