House Bill 5201

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Approves certain new or increased fees adopted by state agencies. Declares emergency, effective on passage.

<u>SECTION 3.</u> For the purpose of carrying out the provisions of ORS 291.055 (1)(e), a fingerprinting fee of \$58, adopted by the Oregon State Board of Nursing and approved by the Oregon Department of Administrative Services, is approved.

SECTION 4. This 2022 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2022 Act takes effect on its passage.
