

Senate Bill 1525

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on Finance and Revenue)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Updates connection date to federal Internal Revenue Code and other provisions of federal tax law.

Takes effect on 91st day following adjournment sine die.

A BILL FOR AN ACT

Relating to connection to federal tax law; creating new provisions; amending ORS 178.300, 178.375, 238A.005, 238A.125, 238A.150, 238A.170, 238A.230, 238A.370, 238A.400, 238A.410, 238A.415, 238A.430, 238A.435, 305.239, 305.494, 305.690, 305.842, 314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097, 317A.100, 458.670, 657.010 and 657B.010; and prescribing an effective date.

Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 178.300 is amended to read:

178.300. As used in ORS 178.300 to 178.360:

(1) "Account" means an individual account established in accordance with ORS 178.300 to 178.360.

(2) "Account owner" means the person who has the right to withdraw funds from the account. The account owner may also be the designated beneficiary of the account.

(3) "Board" means the Oregon 529 Savings Board established under ORS 178.310.

(4) "Designated beneficiary" means, except as provided in ORS 178.350, the individual designated at the time the account is opened as having the right to receive a qualified withdrawal for the payment of qualified higher education expenses, or if the designated beneficiary is replaced in accordance with ORS 178.350, the replacement.

(5) "Financial institution" means a bank, a commercial bank, a national bank, a savings bank, a savings and loan, a thrift institution, a credit union, an insurance company, a trust company, a mutual fund, an investment firm or other similar entity authorized to do business in this state.

(6) "Higher education institution" means an eligible education institution as defined in section 529(e)(5) of the Internal Revenue Code.

(7) "Internal Revenue Code" means the federal Internal Revenue Code as amended and in effect on *[April 1]* **December 31**, 2021.

(8) "Member of the family" shall have the same meaning as contained in section 529(e) of the Internal Revenue Code.

(9) "Network" means the Oregon 529 Savings Network established under ORS 178.305.

(10) "Nonqualified withdrawal" means a withdrawal from an account that is not a qualified withdrawal.

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (11) “Qualified higher education expenses” means tuition and other permitted expenses as set
2 forth in section 529(e) of the Internal Revenue Code for the enrollment or attendance of a designated
3 beneficiary at a higher education institution, expenses associated with registered apprenticeship
4 programs described in section 529(c)(8) of the Internal Revenue Code and amounts paid as principal
5 or interest on a qualified education loan to the extent allowed under section 529(c)(9) of the Internal
6 Revenue Code.

7 (12) “Qualified withdrawal” means a withdrawal made as prescribed under ORS 178.355 and
8 made:

9 (a) From an account to pay the qualified higher education expenses of the designated benefi-
10 cary;

11 (b) As the result of the death or disability of the designated beneficiary;

12 (c) As the result of a scholarship, allowance or payment described in section 135(d)(1)(A), (B)
13 or (C) of the Internal Revenue Code that is received by the designated beneficiary, but only to the
14 extent of the amount of the scholarship, allowance or payment; or

15 (d) As a rollover or change in the designated beneficiary described in ORS 178.350.

16 **SECTION 2.** ORS 178.375 is amended to read:

17 178.375. As used in this section and ORS 178.380 and 178.385:

18 (1) “ABLE account” means an account established by an eligible individual, owned by the eli-
19 gible individual and maintained under the qualified ABLE program established by the Oregon 529
20 Savings Board under ORS 178.380.

21 (2) “ABLE Act” means the Stephen Beck, Jr., Achieving a Better Life Experience Act of 2014
22 (Division B of P.L. 113-295).

23 (3) “Designated beneficiary” has the same meaning as contained in section 529A of the Internal
24 Revenue Code.

25 (4) “Eligible individual” has the same meaning as contained in section 529A of the Internal Re-
26 venue Code.

27 (5) “Internal Revenue Code” means the federal Internal Revenue Code as amended and in effect
28 on [April 1] **December 31, 2021**.

29 (6) “Qualified disability expense” has the same meaning as contained in section 529A of the
30 Internal Revenue Code.

31 **SECTION 3.** ORS 238A.005 is amended to read:

32 238A.005. For the purposes of this chapter:

33 (1) “Active member” means a member of the pension program or the individual account program
34 of the Oregon Public Service Retirement Plan who is actively employed in a qualifying position.

35 (2) “Actuarial equivalent” means a payment or series of payments having the same value as the
36 payment or series of payments replaced, computed on the basis of interest rate and mortality as-
37 sumptions adopted by the board.

38 (3) “Board” means the Public Employees Retirement Board.

39 (4) “Eligible employee” means a person who performs services for a participating public em-
40 ployer, including persons considered employees of a participating public employer under 26 U.S.C.
41 3121(d)(2), as in effect on [December 31, 2019] **January 1, 2022**, and elected officials other than
42 judges. “Eligible employee” does not include:

43 (a) Persons engaged as independent contractors;

44 (b) Aliens working under a training or educational visa;

45 (c) Persons provided sheltered employment or make-work by a public employer;

- 1 (d) Persons categorized by a participating public employer as student employees;
- 2 (e) Any person who is in custody in a state institution;
- 3 (f) Employees of foreign trade offices of the Oregon Business Development Department who live
4 and perform services in foreign countries under the provisions of ORS 285A.075 (1)(g);
- 5 (g) An employee actively participating in an alternative retirement program established under
6 ORS 353.250 or an optional retirement plan established under ORS 341.551;
- 7 (h) Employees of a public university listed in ORS 352.002 who are actively participating in an
8 optional retirement plan offered under ORS 243.815;
- 9 (i) Persons employed in positions classified as post-doctoral scholar positions by a public uni-
10 versity listed in ORS 352.002, or by the Oregon Health and Science University, under ORS 350.370;
- 11 (j) Any employee who belongs to a class of employees that was not eligible on August 28, 2003,
12 for membership in the system under the provisions of ORS chapter 238 or other law;
- 13 (k) Any person who belongs to a class of employees who are not eligible to become members
14 of the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);
- 15 (L) Any person who is retired under ORS 238A.100 to 238A.250 or ORS chapter 238 and who
16 continues to receive retirement benefits while employed; and
- 17 (m) Judges.
- 18 (5) “Firefighter” means:
- 19 (a) A person employed by a local government, as defined in ORS 174.116, whose primary job
20 duties include the fighting of fires;
- 21 (b) The State Fire Marshal, the chief deputy state fire marshal and deputy state fire marshals;
- 22 (c) An employee of the State Fire Marshal whose primary duties include fire investigation, fire
23 prevention, fire safety, fire control or fire suppression;
- 24 (d) An employee of the State Forestry Department who is certified by the State Forester as a
25 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
26 fires as described in ORS 477.064; and
- 27 (e) An employee of the Oregon Military Department whose primary duties include fighting
28 structural, aircraft, wildland or other fires.
- 29 (6) “Fund” means the Public Employees Retirement Fund.
- 30 (7)(a) “Hour of service” means:
- 31 (A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment
32 by a participating public employer for performance of duties in a qualifying position; and
- 33 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave
34 during which an employee does not perform duties but for which the employee is directly or indi-
35 rectly paid or entitled to payment by a participating public employer for services in a qualifying
36 position, as long as the hour is within the number of hours regularly scheduled for the performance
37 of duties during the period of vacation, holiday, illness, incapacity, jury duty, military duty or au-
38 thorized leave.
- 39 (b) “Hour of service” does not include any hour for which payment is made or due under a plan
40 maintained solely for the purpose of complying with applicable unemployment compensation laws.
- 41 (8) “Inactive member” means a member of the pension program or the individual account pro-
42 gram of the Oregon Public Service Retirement Plan whose membership has not been terminated, who
43 is not a retired member and who is not employed in a qualifying position.
- 44 (9) “Individual account program” means the defined contribution individual account program of
45 the Oregon Public Service Retirement Plan established under ORS 238A.025.

1 (10) "Institution of higher education" means a public university listed in ORS 352.002, the
2 Oregon Health and Science University or a community college, as defined in ORS 341.005.

3 (11) "Member" means an eligible employee who has established membership in the pension pro-
4 gram or the individual account program of the Oregon Public Service Retirement Plan and whose
5 membership has not been terminated under ORS 238A.110 or 238A.310.

6 (12) "Participating public employer" means a public employer as defined in ORS 238.005 that
7 provides retirement benefits for employees of the public employer under the system.

8 (13) "Pension program" means the defined benefit pension program of the Oregon Public Service
9 Retirement Plan established under ORS 238A.025.

10 (14) "Police officer" means a police officer as described in ORS 238.005.

11 (15) "Qualifying position" means one or more jobs with one or more participating public em-
12 ployers in which an eligible employee performs 600 or more hours of service in a calendar year,
13 excluding any service in a job for which benefits are not provided under the Oregon Public Service
14 Retirement Plan pursuant to ORS 238A.070 (2).

15 (16) "Retired member" means a pension program member who is receiving a pension as provided
16 in ORS 238A.180 to 238A.195.

17 (17)(a) "Salary" means the remuneration paid to an active member in return for services to the
18 participating public employer, including remuneration in the form of living quarters, board or other
19 items of value, to the extent the remuneration is, or would be if the member were an Oregon resi-
20 dent, includable in the employee's taxable income under Oregon law. "Salary" includes the addi-
21 tional amounts specified in paragraph (b) of this subsection, but does not include the amounts
22 specified in paragraph (c) of this subsection, regardless of whether those amounts are includable in
23 taxable income.

24 (b) "Salary" includes the following amounts:

25 (A) Payments of employee and employer money into a deferred compensation plan that are made
26 at the election of the employee.

27 (B) Contributions to a tax-sheltered or deferred annuity that are made at the election of the
28 employee.

29 (C) Any amount that is contributed to a cafeteria plan or qualified transportation fringe benefit
30 plan by the employer at the election of the employee and that is not includable in the taxable in-
31 come of the employee by reason of 26 U.S.C. 125 or 132(f)(4), as in effect on *[April 1] December*
32 **31, 2021**.

33 (D) Any amount that is contributed to a cash or deferred arrangement by the employer at the
34 election of the employee and that is not included in the taxable income of the employee by reason
35 of 26 U.S.C. 402(e)(3), as in effect on *[April 1] December 31, 2021*.

36 (E) Retroactive payments described in ORS 238.008.

37 (F) The amount of an employee contribution to the individual account program that is paid by
38 the employer and deducted from the compensation of the employee, as provided under ORS 238A.335
39 (1) and (2)(a).

40 (G) The amount of an employee contribution to the individual account program that is not paid
41 by the employer under ORS 238A.335.

42 (H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS
43 652.190.

44 (c) "Salary" does not include the following amounts:

45 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the

1 employer.

2 (B) Payments made on account of an employee's death.

3 (C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paid
4 leave.

5 (D) Any severance payment, accelerated payment of an employment contract for a future period
6 or advance against future wages.

7 (E) Any retirement incentive, retirement bonus or retirement gratuitous payment.

8 (F) Payment for a leave of absence after the date the employer and employee have agreed that
9 no future services in a qualifying position will be performed.

10 (G) Payments for instructional services rendered to public universities listed in ORS 352.002 or
11 the Oregon Health and Science University when those services are in excess of full-time employment
12 subject to this chapter. A person employed under a contract for less than 12 months is subject to
13 this subparagraph only for the months covered by the contract.

14 (H) The amount of an employee contribution to the individual account program that is paid by
15 the employer and is not deducted from the compensation of the employee, as provided under ORS
16 238A.335 (1) and (2)(b).

17 (I) Compensation described and authorized under ORS 341.556 that is not paid by the community
18 college employing the faculty member.

19 (J) Compensation described and authorized under ORS 352.232 that is not paid by the public
20 university employing the officer or employee.

21 (K) Compensation described and authorized under ORS 353.270 that is not paid by Oregon
22 Health and Science University.

23 (L) For years before 2020, any amount in excess of \$200,000 for a calendar year. If any period
24 over which salary is determined is less than 12 months, the \$200,000 limitation for that period shall
25 be multiplied by a fraction, the numerator of which is the number of months in the determination
26 period and the denominator of which is 12. The board shall adopt rules adjusting this dollar limit
27 to incorporate cost-of-living adjustments authorized by the Internal Revenue Service.

28 (M) For years beginning on or after January 1, 2020, any amount in excess of \$195,000 for a
29 calendar year. If any period over which salary is determined is less than 12 months, the \$195,000
30 limitation for that period shall be multiplied by a fraction, the numerator of which is the number
31 of months in the determination period and the denominator of which is 12. On January 1 of each
32 year, the board shall adjust the dollar limit provided by this subparagraph to reflect any percentage
33 changes in the Consumer Price Index for All Urban Consumers, West Region (All Items), as pub-
34 lished by the Bureau of Labor Statistics of the United States Department of Labor.

35 (18) "System" means the Public Employees Retirement System.

36 (19) "Workers' compensation benefits" means:

37 (a) Payments made under ORS chapter 656; or

38 (b) Payments provided in lieu of workers' compensation benefits under ORS 656.027 (6).

39 **SECTION 4.** ORS 238A.125 is amended to read:

40 238A.125. (1) Upon retiring at normal retirement age, a vested pension program member shall
41 be paid an annual pension for the life of the member as follows:

42 (a) For service as a police officer or firefighter, 1.8 percent of final average salary multiplied
43 by the number of years of retirement credit attributable to service as a police officer or firefighter.

44 (b) For service as other than a police officer or firefighter, 1.5 percent of final average salary
45 multiplied by the number of years of retirement credit attributable to service as other than a police

1 officer or firefighter.

2 (2) Notwithstanding any provision of ORS 238A.100 to 238A.250, the annual benefit payable to
3 a member under the pension program and under any other tax-qualified defined benefit plan main-
4 tained by the participating public employer may not exceed the applicable limitations set forth in
5 26 U.S.C. 415(b), as in effect on [April 1] **December 31**, 2021. The Public Employees Retirement
6 Board shall adopt rules for the administration of this limitation, including adjustments in the annual
7 dollar limitation to reflect cost-of-living adjustments authorized by the Internal Revenue Service.

8 (3) The board shall make no actuarial adjustment in a member's pension calculated under this
9 section by reason of the member's retirement after normal retirement age.

10 **SECTION 5.** ORS 238A.150 is amended to read:

11 238A.150. (1) Notwithstanding any other provision of ORS 238A.100 to 238A.250, an eligible em-
12 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-
13 vices, and who subsequently returns to employment with a participating public employer with
14 reemployment rights under federal law, is entitled to accrue retirement credit, credit toward the
15 probationary period required by ORS 238A.100 and credit toward the vesting requirements of ORS
16 238A.115 under rules adopted by the Public Employees Retirement Board pursuant to subsection (2)
17 of this section.

18 (2) The board shall adopt rules establishing benefits and service credit for any period of service
19 in the uniformed services by an employee described in subsection (1) of this section. For the purpose
20 of adopting rules under this subsection, the board shall consider and take into account all federal
21 law relating to benefits and service credit for any period of service in the uniformed services, in-
22 cluding 26 U.S.C. 414(u), as in effect on [April 1] **December 31**, 2021. Benefits and service credit
23 under rules adopted by the board pursuant to this subsection may not exceed benefits and service
24 credit required under federal law for periods of service in the uniformed services.

25 **SECTION 6.** ORS 238A.170 is amended to read:

26 238A.170. (1) An active member of the pension program who is 72 years of age or older must
27 retire not later than April 1 of the calendar year following the calendar year in which the member
28 terminates employment with all participating public employers. An inactive member of the pension
29 program must retire not later than April 1 of the calendar year following the calendar year in which
30 the member attains 72 years of age.

31 (2) Notwithstanding any other provision of ORS 238A.100 to 238A.250, the entire interest of a
32 member of the pension program must be distributed over a time period commencing no later than
33 the required beginning date set forth in subsection (1) of this section, and must be distributed in a
34 manner that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regu-
35 lations implementing that section, as in effect on [April 1, 2021] **January 1, 2022**. The Public Em-
36 ployees Retirement Board shall adopt rules implementing those minimum distribution requirements.

37 **SECTION 7.** ORS 238A.230 is amended to read:

38 238A.230. (1) If a member of the pension program who is vested dies before the member's effec-
39 tive date of retirement, the Public Employees Retirement Board shall pay the death benefit provided
40 for in this section to:

41 (a) The spouse of the member to the extent not provided to a former spouse in accordance with
42 a judgment or order under ORS 238.465;

43 (b) The former spouse of the member as provided in a judgment or order under ORS 238.465; or

44 (c) Any other person who is constitutionally required to be treated in the same manner as a
45 spouse for the purpose of retirement benefits.

1 (2) The death benefit to be paid under this subsection is for the life of the member's spouse,
2 former spouse or other person who is constitutionally required to be treated in the same manner
3 as a spouse, and is:

4 (a) If the member dies before the earliest retirement date for the member under ORS 238A.165,
5 the actuarial equivalent of 50 percent of the pension that would otherwise have been paid to the
6 deceased member, which shall be calculated as if the member became an inactive member on the
7 date of death and retired at the earliest retirement date for the member as described in ORS
8 238A.165;

9 (b) If the member dies on or after the earliest retirement date for the member under ORS
10 238A.165 and before normal retirement age under ORS 238A.160, the actuarial equivalent of the
11 pension that would otherwise have been paid to the deceased member, which shall be calculated as
12 if the member retired under ORS 238A.185 and as if the member's retirement date was the first of
13 the month following the date of death of the member; or

14 (c) If the member dies on or after reaching normal retirement age as described in ORS 238A.160,
15 the actuarial equivalent of the pension that would otherwise have been paid to the deceased mem-
16 ber, which shall be calculated under ORS 238A.125 as if the member's retirement date was the first
17 of the month following the date of death of the member.

18 (3) The death benefit provided under this section is first effective on the first day of the month
19 following the date of death of the member. The surviving spouse, former spouse or other person
20 entitled to the death benefit may elect to delay payment of the death benefit, which shall be
21 actuarially adjusted for age and interest when payments commence, but payment must commence
22 no later than December 31 of the calendar year in which the member would have reached 72 years
23 of age.

24 (4) Notwithstanding any other provision of ORS 238A.100 to 238A.250, distributions of death
25 benefits under the pension program must comply with the minimum distribution requirements of 26
26 U.S.C. 401(a)(9) and the regulations implementing that section, as in effect on [April 1, 2021] **Janu-**
27 **ary 1, 2022**. The board shall adopt rules implementing those minimum distribution requirements.

28 **SECTION 8.** ORS 238A.370 is amended to read:

29 238A.370. Notwithstanding any other provision of ORS 238A.300 to 238A.415, the annual addition
30 to the employee and employer accounts of a member of the individual account program for a cal-
31 endar year, together with the annual additions to the accounts of the member under any other de-
32 fined contribution plan maintained by the participating public employer for a calendar year, may
33 not exceed the lesser of \$40,000, or 100 percent of the member's compensation for that calendar year.
34 For purposes of this section, "annual addition" has the meaning given that term in 26 U.S.C.
35 415(c)(2), as in effect on [April 1] **December 31**, 2021, and "compensation" has the meaning given
36 the term "participant's compensation" in 26 U.S.C. 415(c)(3), as in effect on [April 1] **December 31**,
37 2021. The Public Employees Retirement Board shall adopt rules for the administration of this limi-
38 tation, including adjustments in the annual dollar limitation to reflect cost-of-living adjustments au-
39 thorized by the Internal Revenue Service.

40 **SECTION 9.** ORS 238A.400 is amended to read:

41 238A.400. (1) Upon retirement on or after the earliest retirement date, as described in ORS
42 238A.165, a member of the individual account program shall receive in a lump sum the amounts in
43 the member's employee account, rollover account and employer account to the extent the member
44 is vested in those accounts under ORS 238A.320.

45 (2) In lieu of a lump sum payment under subsection (1) of this section, a member of the individ-

1 ual account program may elect to receive the amounts in the member's employee account and em-
2 ployer account, to the extent the member is vested in those accounts under ORS 238A.320, in
3 substantially equal installments paid over a period of 5, 10, 15 or 20 years, or over a period that is
4 equal to the anticipated life span of the member as actuarially determined by the Public Employees
5 Retirement Board. Installments may be made on a monthly, quarterly or annual basis. In no event
6 may the period selected by the member exceed the time allowed by the minimum distribution re-
7 quirements described in subsection (5) of this section. The board shall by rule establish the manner
8 in which installments will be adjusted to reflect investment gains and losses on the unpaid balance
9 during the payout period elected by the member under this subsection. The board by rule may es-
10 tablish minimum monthly amounts payable under this subsection. The board may require that a
11 lump sum payment, or an installment schedule different than the schedules provided for in this
12 subsection, be used to pay the vested amounts in the member's accounts if those amounts are not
13 adequate to generate the minimum monthly amounts specified by the rule.

14 (3) A member of the individual account program electing to receive installments under sub-
15 section (2) of this section must designate a beneficiary or beneficiaries. In the event the member dies
16 before all amounts in the employee and vested employer accounts are paid, all remaining installment
17 payments shall be made to the beneficiary or beneficiaries designated by the member. A beneficiary
18 may elect to receive a lump sum distribution of the remaining amounts.

19 (4) A member who is entitled to receive retirement benefits under ORS chapter 238 may receive
20 vested amounts in the member's employee account, rollover account and employer account in the
21 manner provided by this section when the member retires for service under the provisions of ORS
22 chapter 238.

23 (5) Notwithstanding any other provision of ORS 238A.300 to 238A.415, the entire interest of a
24 member of the individual account program must be distributed over a time period commencing no
25 later than the latest retirement date set forth in ORS 238A.170, and must be distributed in a manner
26 that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regulations im-
27 plementing that section, as in effect on [April 1, 2021] **January 1, 2022**. The board shall adopt rules
28 implementing those minimum distribution requirements.

29 **SECTION 10.** ORS 238A.410 is amended to read:

30 238A.410. (1)(a) If a member of the individual account program dies before retirement, the
31 amounts in the member's employee account, rollover account and employer account, to the extent
32 the member is vested in those accounts under ORS 238A.320, shall be paid in a lump sum to the
33 beneficiary or beneficiaries designated by the member for the purposes of this section.

34 (b) If a member of the individual account program dies before retirement, the amounts in the
35 employee pension stability account established for the member under ORS 238A.353 shall be applied
36 by the Public Employees Retirement Board to pay the costs of any benefit payable under ORS
37 238.395 or 238A.230 that accrues on or after July 1, 2020. If the amounts in the employee pension
38 stability account exceed the costs of the benefit payable under ORS 238.395 or 238A.230 that accrues
39 on or after July 1, 2020, the excess amounts shall be paid in a lump sum to the beneficiary or ben-
40 efiiciaries designated by the member for the purposes of this section.

41 (2) If a member of the individual account program is married at the time of death, or there exists
42 at the time of death any other person who is constitutionally required to be treated in the same
43 manner as a spouse for the purpose of retirement benefits, the spouse or other person shall be the
44 beneficiary for purposes of the death benefit payable under this section unless the spouse or other
45 person consents to the designation of a different beneficiary or beneficiaries before the designation

1 has been made and the consent has not been revoked by the spouse or other person as of the time
 2 of the member's death. Consent and revocation of consent must be in writing, acknowledged by a
 3 notary public, and submitted to the Public Employees Retirement Board in accordance with rules
 4 adopted by the board. If the member's spouse is designated as the member's beneficiary and the
 5 marriage of the member and spouse is subsequently dissolved, the former spouse shall be treated as
 6 predeceasing the member for purposes of this section, unless the member expressly designates the

1 (b) "Household income" means the aggregate income of the taxpayer and the spouse of the tax-
2 payer who reside in the household, that was received during the taxable year for which a credit is
3 claimed, except that "household income" does not include Social Security benefits received by the
4 taxpayer or the spouse of the taxpayer.

5 (c) "Income" means "adjusted gross income" as defined in the federal Internal Revenue Code,
6 as amended and in effect on [April 1] **December 31**, 2021, even when the amendments take effect
7 or become operative after that date, relating to the measurement of taxable income of individuals,
8 estates and trusts, with the following modifications:

9 (A) There shall be added to adjusted gross income the following items of otherwise exempt in-
10 come:

11 (i) The gross amount of any otherwise exempt pension less return of investment, if any.

12 (ii) Child support received by the taxpayer.

13 (iii) Inheritances.

14 (iv) Gifts and grants, the sum of which are in excess of \$500 per year.

15 (v) Amounts received by a taxpayer or spouse of a taxpayer for support from a parent who is
16 not a member of the taxpayer's household.

17 (vi) Life insurance proceeds.

18 (vii) Accident and health insurance proceeds, except reimbursement of incurred medical ex-
19 penses.

20 (viii) Personal injury damages.

21 (ix) Sick pay that is not included in federal adjusted gross income.

22 (x) Strike benefits excluded from federal gross income.

23 (xi) Worker's compensation, except for reimbursement of medical expense.

24 (xii) Military pay and benefits.

25 (xiii) Veteran's benefits.

26 (xiv) Payments received under the federal Social Security Act that are excluded from federal
27 gross income.

28 (xv) Welfare payments, except as follows:

29 (I) Payments for medical care, drugs and medical supplies, if the payments are not made directly
30 to the welfare recipient;

31 (II) In-home services authorized and approved by the Department of Human Services; and

32 (III) Direct or indirect reimbursement of expenses paid or incurred for participation in work or
33 training programs.

34 (xvi) Nontaxable dividends.

35 (xvii) Nontaxable interest not included in federal adjusted gross income.

36 (xviii) Rental allowance paid to a minister that is excluded from federal gross income.

37 (xix) Income from sources without the United States that is excluded from federal gross income.

38 (B) Adjusted gross income shall be increased due to the disallowance of the following de-
39 ductions:

40 (i) The amount of the net loss, in excess of \$1,000, from all dispositions of tangible or intangible
41 properties.

42 (ii) The amount of the net loss, in excess of \$1,000, from the operation of a farm or farms.

43 (iii) The amount of the net loss, in excess of \$1,000, from all operations of a trade or business,
44 profession or other activity entered into for the production or collection of income.

45 (iv) The amount of the net loss, in excess of \$1,000, from tangible or intangible property held for

1 the production of rents, royalties or other income.

2 (v) The amount of any net operating loss carryovers or carrybacks included in federal adjusted
3 gross income.

4 (vi) The amount, in excess of \$5,000, of the combined deductions or other allowances for depre-
5 ciation, amortization or depletion.

6 (vii) The amount added or subtracted, as required within the context of this section, for adjust-
7 ments made under ORS 316.680 (2)(d) and 316.707 to 316.737.

8 (C) "Income" does not include the following:

9 (i) Any governmental grant that must be used by the taxpayer for rehabilitation of the home-
10 stead of the taxpayer.

11 (ii) Any refund of Oregon personal income taxes that were imposed under this chapter.

12 (d) "Net pension income" means:

13 (A) For eligible individuals filing a joint return, the lesser of the pension income of the eligible
14 individuals received during the taxable year or the excess, if any, of \$15,000 over the sum of the
15 following amounts:

16 (i) Any Social Security benefits received by the eligible individual, or by the spouse of the in-
17 dividual, during the taxable year; and

18 (ii) The excess, if any, of household income over \$30,000.

19 (B) For an eligible individual filing a return other than a joint return, the lesser of the pension
20 income of the eligible individual received during the taxable year or the excess, if any, of \$7,500
21 over the sum of the following amounts:

22 (i) Any Social Security benefits received by the eligible individual during the taxable year; and

23 (ii) The excess, if any, of household income over \$15,000.

24 (e) "Pension income" means income included in Oregon taxable income from:

25 (A) Distributions from or pursuant to an employee pension benefit plan, as defined in section

38 or trust or simplified employee pension which satisfies the requirements of section 408 of the Inter-

36 in subsection (11) of this section and ORS 317.650 to 317.665.

37 (10) "Taxable income or loss" means the taxable income or loss determined, or in the case of a
38 corporation for which no federal taxable income or loss is determined, as would be determined, un-
39 der chapter 1, Subtitle A of the Internal Revenue Code and any other laws of the United States

39 tate loans.

40 (i) “Qualified borrower” means any borrower that is a sponsoring entity that has a controlling
41 interest in the real property that is financed by a qualified loan. A controlling interest includes a
42 controlling interest in the general partner of a limited partnership that owns the real property.

43 (j) “Qualified loan” means:

44 (A) A loan that meets the criteria stated in subsection (5) of this section or that is made to re-
45 finance a loan that meets the criteria described in subsection (5) of this section; or

1 (B) The purchase by a lending institution of bonds, the proceeds of which are used to finance
2 or refinance a loan that meets the criteria described in subsection (5) of this section.

3 (k) "Sponsoring entity" means a nonprofit corporation, nonprofit cooperative, state governmental

21 retail dealer, distributor, manufacturer or seller, an amount equal to the federal and state excise
22 taxes paid by any person on or for such cigarettes or tobacco products under subtitle E of the
23 Internal Revenue Code or ORS chapter 323;

24 (S) In the case of receipts from the sale of malt beverages or wine, as defined in ORS 471.001,
25 cider, as defined in ORS 471.023 or distilled liquor, as defined in ORS 471.001, by a person holding
26 a license issued under ORS chapter 471, an amount equal to the federal and state excise taxes paid
27 by any person on or for such malt beverages, wine or distilled liquor under subtitle E of the Internal
28 Revenue Code or ORS chapter 471 or 473, and any amount paid to the Oregon Liquor and Cannabis
29 Commission for sales of distilled spirits by an agent appointed under ORS 471.750;

35 (U) Local taxes collected by a restaurant or other food establishment on sales of meals, prepared
36 food or beverages;

37 (V) Tips or gratuities collected by a restaurant or other food establishment and passed on to

39 (W) Receipts realized by a vehicle dealer certified under ORS 822.020 or a person described in
40 ORS 320.400 (8)(a)(B) from the sale or other transfer of a motor vehicle, as defined in ORS 801.360,
41 to another vehicle dealer for the purpose of resale by the transferee vehicle dealer, but only if the
42 sale or other transfer was based upon the transferee's need to meet a specific customer's preference

11 be used as purse money;

12 (AA) Receipts of residential care facilities as defined in ORS 443.400 or in-home care agencies
13 as defined in ORS 443.305, to the extent that the receipts are derived from or received as compen-
14 sation for providing services to a medical assistance or Medicare recipient;

15 (BB) Dividends received;

16 (CC) Distributive income received from a pass-through entity;

17 (DD) Receipts from sales to a wholesaler in this state, if the seller receives certification at the
18 time of sale from the wholesaler that the wholesaler will sell the purchased property outside this
19 state;

20 (EE) Receipts from the wholesale or retail sale of groceries, including receipts of a person that
21 owns groceries at the time of sale and compensation of any consignee engaged in effecting the sale
22 of groceries on behalf the owner of the groceries, but only to the extent that the compensation re-
23 lates to grocery sales;

24 (FF) Receipts from transactions among members of a unitary group;

25 (GG) Moneys, including public purpose charge moneys collected under ORS 757.612 and moneys
26 collected to plan for and pursue cost-effective energy efficiency resources under ORS 757.054, that
27 are collected from customers, passed to a utility and approved by the Public Utility Commission and
28 that support energy conservation, renewable resource acquisition and low-income assistance pro-
29 grams;

30 (HH) Moneys collected by a utility from customers for the payment of loans through on-bill fi-
31 nancing;

32 (II) Surcharges collected under ORS 757.736;

33 (JJ) Moneys passed to a utility by the Bonneville Power Administration for the purpose of
34 effectuating the Regional Power Act Exchange credits or pursuant to any settlement associated with
35 the exchange credit;

36 (KK) Moneys collected or recovered, by entities listed in ORS 756.310, cable operators as de-
37 fined in 47 U.S.C. 522(5), telecommunications carriers as defined in 47 U.S.C. 153(51) and providers
38 of information services as defined in 47 U.S.C. 153(24), for fees payable under ORS 756.310, right-of-
39 way fees, franchise fees, privilege taxes, federal taxes and local taxes;

40 (LL) Charges paid to the Residential Service Protection Fund required by chapter 290, Oregon
41 Laws 1987;

42 (MM) Universal service surcharge moneys collected or recovered and paid into the universal
43 service fund established in ORS 759.425;

44 (NN) Moneys collected for public purpose funding as described in ORS 759.430;

45 (OO) Moneys collected or recovered and paid into the federal universal service fund as deter-

1 mined by the Federal Communications Commission;

2 (PP) In the case of a seller or provider of telecommunications services, the amount of tax im-
3 posed under ORS 403.200 for access to the emergency communications system that is collected from
4 subscribers or consumers;

5 (QQ) In the case of a transient lodging tax collector, the amount of tax imposed under ORS
6 320.305 and of any local transient lodging tax imposed upon the occupancy of transit lodging;

7 (RR) In the case of a seller of bicycles, the amount of tax imposed under ORS 320.415 upon retail
8 sales of bicycles;

45 (k) Hospitals subject to assessment under ORS 414.855, long term care facilities subject to as-

1 sessment under ORS 409.801 or any entity subject to assessment under ORS 414.880 or section 3 or
2 5, chapter 538, Oregon Laws 2017.

3 (L) Manufactured dwelling park nonprofit cooperatives organized under ORS chapter 62.

4 (5) "Financial institution" has the meaning given that term in ORS 314.610, except that "finan-
5 cial institution" does not include a credit union.

6 (6)(a) "FR Y-9" means the consolidated or parent-only financial statements that a holding com-
7 pany is required to file with the Federal Reserve Board pursuant to 12 U.S.C. 1844.

8 (b) In the case of a holding company required to file both consolidated and parent-only financial
9 statements, "FR Y-9" means the consolidated financial statements that the holding company is re-
10 quired to file.

11 (7) "Governmental entity" means:

12 (a) The United States and any of its unincorporated agencies and instrumentalities.

13 (b) Any incorporated agency or instrumentality of the United States wholly owned by the United
14 States or by a corporation wholly owned by the United States.

15 (c) The State of Oregon and any of its unincorporated agencies and instrumentalities.

16 (d) Any county, city, district or other political subdivision of the state.

21 (9)(a) "Hedging transaction" means a hedging transaction as defined in section 1221 of the
22 Internal Revenue Code or a transaction accorded hedge accounting treatment under Financial Ac-
23 counting Standards Board Statement No. 133.

24 (b) "Hedging transaction" does not include a transaction in which an actual transfer of title of
25 real or tangible property to another entity occurs.

26 (10) "Insurer" has the meaning given that term in ORS 317.010.

27 (11) "Internal Revenue Code," except where the Legislative Assembly has provided otherwise,
28 refers to the laws of the United States or to the Internal Revenue Code as they are amended and
29 in effect on *[April 1]* **December 31**, 2021.

30 (12) "Labor costs" means total compensation of all employees, not to include compensation paid
31 to any single employee in excess of \$500,000.

32 (13)(a) "Motor vehicle fuel or any other product used for the propulsion of motor vehicles"
33 means:

34 (A) Motor vehicle fuel as defined in ORS 319.010; and

35 (B) Fuel the use of which in a motor vehicle is subject to taxation under ORS 319.530.

7 fiduciary organization, for the deposit of funds into a financial institution by the account holder and

10 fiduciary organization.

41 (19) "Medical leave" means leave from work taken by a covered individual that is made neces-
42 sary by the individual's own serious health condition.

43 (20) "Parent" means:

44 (a) A biological parent, adoptive parent, stepparent or foster parent of a covered individual;

45 (b) A person who was a foster parent of a covered individual when the covered individual was

1 a minor;

2 (c) A person designated as the legal guardian of a covered individual at the time the covered
3 individual was a minor or required a legal guardian;

4 (d) A person with whom a covered individual was or is in a relationship of in loco parentis; or

5 (e) A parent of a covered individual's spouse or domestic partner who meets a description under
6 paragraphs (a) to (d) of this subsection.

7 (21) "Safe leave" means leave taken for any purpose described in ORS 659A.272.

8 (22) "Self-employed individual" means:

9 (a) An individual who has self-employment income as defined in section 1402(b) of the Internal
10 Revenue Code as amended and in effect on [April 1] **December 31, 2021**; or

11 (b) An independent contractor as defined in ORS 670.600.

12 (23) "Serious health condition" has the meaning given that term in ORS 659A.150.

13 (24) "Third party administrator" means a third party that enters into an agreement with the
14 Director of the Employment Department to implement and administer the paid family and medical
15 leave program established under this chapter.

16 (25) "Tribal government" has the meaning given that term in ORS 181A.940.

17 (26) "Wages" has the meaning given that term in ORS 657.105.

18 **SECTION 30. (1) Except as provided in subsections (2) and (3) of this section, the**
19 **amendments to statutes by sections 1 to 29 of this 2022 Act apply to transactions or activities**
20 **occurring on or after January 1, 2022, in tax years beginning on or after January 1, 2022.**

21 **(2) The effective and applicable dates, and the exceptions, special rules and coordination**
22 **with the Internal Revenue Code, as amended, relative to those dates, contained in the**
23 **American Rescue Plan Act of 2021 (P.L. 117-2) and the Infrastructure Investment and Jobs**
24 **Act (P.L. 117-58) and other federal law amending the Internal Revenue Code and enacted**
25 **before January 1, 2022, apply for Oregon personal income and corporate excise and income**
26 **tax purposes, to the extent they can be made applicable, in the same manner as they are**
27 **applied under the Internal Revenue Code and related federal law.**

28 **(3)(a) If a deficiency is assessed against any taxpayer for a tax year beginning before**
29 **January 1, 2022, and the deficiency or any portion thereof is attributable to any retroactive**
30 **treatment under the amendments to ORS 178.300, 178.375, 305.239, 305.494, 305.690, 305.842,**
31 **314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and 317A.100 by sections 1, 2**
32 **and 14 to 26 of this 2022 Act, then any interest or penalty assessed under ORS chapter 305,**
33 **314, 315, 316, 317, 317A or 318 with respect to the deficiency or portion thereof shall be can-**
34 **celed.**

35 **(b) If a refund is due any taxpayer for a tax year beginning before January 1, 2022, and**
36 **the refund or any portion thereof is due the taxpayer on account of any retroactive treat-**
37 **ment under the amendments to ORS 178.300, 178.375, 305.239, 305.494, 305.690, 305.842, 314.011,**
38 **314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and 317A.100 by sections 1, 2 and 14**
39 **to 26 of this 2022 Act, for a tax year beginning before January 1, 2022, then notwithstanding**
40 **ORS 305.270 or 314.415 or any other law, the refund or portion thereof shall be paid without**
41 **interest.**

42 **(c) Any changes required because of the amendments to ORS 178.300, 178.375, 305.239,**
43 **305.494, 305.690, 305.842, 314.011, 314.306, 315.004, 316.012, 316.147, 316.157, 317.010, 317.097 and**
44 **317A.100 by sections 1, 2 and 14 to 26 of this 2022 Act, for a tax year beginning before January**
45 **1, 2022, shall be made by filing an amended return within the time prescribed by law.**

1 **(d) If a taxpayer fails to file an amended return under paragraph (c) of this subsection,**
2 **the Department of Revenue shall make any changes under paragraph (c) of this subsection**
3 **on the return to which the changes relate within the period specified for issuing a notice of**
4 **deficiency or claiming a refund as otherwise provided by law with respect to that return, or**
5 **within one year after a return for a tax year beginning on or after January 1, 2022, and be-**
6 **fore January 1, 2023, is filed, whichever period expires later.**

7 **SECTION 31. This 2022 Act takes effect on the 91st day after the date on which the 2022**
8 **regular session of the Eighty-first Legislative Assembly adjourns sine die.**
