SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes annual salary of members of Legislative Assembly equal to annual [occupational mean wage estimate for] average wage for all covered employment in Oregon for prior year. Directs that salary of members of Legislative Assembly be adjusted to conform to annual [occupational mean wage estimate] average wage for all covered employment only once every two years.

Applies cost-of-living adjustment to monthly interim expense allowance received by members. Authorizes reimbursement for child care expenses [child care allowance] for members who have children or dependents under 13 years of age. Caps monthly amount of reimbursement and limits reimbursement to specified months during which regular sessions of Legislative Assembly occur.

Applies to pay periods beginning on or after January 1, 2023. Takes effect on 91st day following adjournment sine die.

4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** ORS 171.072 is amended to read:

6 171.072. (1)(a) A member of the Legislative Assembly shall receive for services an annual salary

7 that equals [one step below the maximum step of Salary Range 1 in the Management Service Com-

8 pensation Plan in the executive department as defined in ORS 174.112.] the annual average wage

9 for all covered employment in Oregon, as published for the prior calendar year by the Em-

10 ployment Department.

(b) The adjustment to annual salary described in paragraph (a) of this subsection shall be made only once every two years and shall be applied to pay periods beginning July 1 following the determination of the annual average wage for all covered employment in Oregon.

(c) Notwithstanding paragraph (a) or (b) of this subsection, the amount a member of the

1 within the period that the Legislative Assembly is in session, to be paid with the salary provided for

2 in subsection (1) of this section. Pursuant to procedures determined by the Legislative Adminis-3 tration Committee, a member may draw from an accrued allowance.

(4) A member of the Legislative Assembly shall receive, as an allowance for expenses incurred 4 in the performance of official duties during periods when the legislature is not in session, \$400 for 5 each calendar month or part of a calendar month during those periods, to be paid monthly, and 6 subject to approval of the President of the Senate or Speaker of the House of Representatives, 7 mileage expenses and a per diem determined as provided in subsection (9) of this section for each 8 9 day a member is engaged in the business of legislative interim and statutory committees, including advisory committees and subcommittees of advisory committees, and task forces and for each day 10 a member serves on interstate bodies, advisory committees and other entities on which the member 11 12 serves ex officio, whether or not the entity is a legislative one.

(5) In addition to the mileage and per diem expense payments provided by this section, a member of the Legislative Assembly may receive reimbursement for actual and necessary expenses, subject to approval by the President of the Senate or Speaker of the House of Representatives, for legislative business outside of the state.

17 (6) The President of the Senate and the Speaker of the House of Representatives may delegate 18 to the chairpersons of interim and statutory committees and task forces the approval authority 19 granted to the President and the Speaker by subsection (4) of this section, with respect to expenses 20 incurred in attending any meeting of a particular committee or task force.

(7) Amounts received under subsections (3) to (5) of this section are excluded from gross income 2122and expenditures of the amounts are excluded in computing deductions for purposes of ORS chapter 23316. If there is attached to the personal income return a schedule of all ordinary and necessary business expenses paid during the tax year as a member of the Legislative Assembly, a deduction 2425may be claimed on the return for legislative expenses paid in excess of the amounts received under subsections (3) to (5) of this section. Expenses of members of the Legislative Assembly who are re-2627imbursed by the state for actual expenses for meals and lodging associated with state travel for the same period during which a legislator receives per diem are subject to state income tax. 28

(8) For periods when the Legislative Assembly is not in session, a member of the Legislative Assembly shall receive an expense allowance that is in addition to the amount allowed under subsection (4) of this section. The amount allocated to a member under this subsection must be adjusted based on the geographic area of the member's district to reflect travel expenses necessary to communicate in the district.

(9) The per diem allowance referred to in subsections (3) and (4) of this section shall be the
amount fixed for per diem allowance that is authorized by the United States Internal Revenue Service to be excluded from gross income without itemization.

(10) A member of the Legislative Assembly who has one or more children or dependents under 13 years of age as of the first day of a month shall receive a reimbursement for child care expenses of up to \$1,000, without regard to the number of children or dependents under 13 years of age that the member has, for each of the following months:

(11)(a) The interim expense allowance described in subsection (4) of this section shall be
 adjusted each July 1 by a cost-of-living adjustment equal to the percentage by which the
 monthly averaged U.S. City Average Consumer Price Index for the preceding calendar year

exceeds the monthly averaged U.S. City Average Consumer Price Index for the 2021 calendar 1 $\mathbf{2}$ year. 3 (b) As used in this subsection, "U.S. City Average Consumer Price Index" means the U.S. City Average Consumer Price Index for All Urban Consumers (All Items) as published by the 4 Bureau of Labor Statistics of the United States Department of Labor. $\mathbf{5}$ SECTION 2.
