

Senate Bill 1581

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Chief Justice Martha L. Walters for Judicial Department)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Increases annual salary of judges of Supreme Court, Court of Appeals, circuit courts and Oregon Tax Court.

Declares emergency, effective on passage.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 292.406 is amended to read:

6 292.406. (1)(a) The annual salary of the Chief Judge of the Court of Appeals shall be [*\$154,040*
7 *for the period beginning on January 1, 2019, and ending on June 30, 2020*] **\$171,408 for the period**
8 **beginning on December 1, 2021, and ending on June 30, 2022.**

9 [*(b) On July 1, 2020, the annual salary of the Chief Judge of the Court of Appeals, as adjusted*
10 *under ORS 292.428, shall be increased by \$5,000.*]

11 **(b) On July 1, 2022, the annual salary of the Chief Judge of the Court of Appeals shall be**
12 **\$188,544.**

13 **(c) On January 1, 2023, the annual salary of the Chief Judge of the Court of Appeals shall**

 26 *ORS 292.428, shall be increased by \$5,000.*]

27 **(2) On July 1, 2022, the annual salary of the judge of the Oregon Tax Court shall be**
 28 **\$179,064.**

29 **(3) On January 1, 2023, the annual salary of the judge of the Oregon Tax Court shall be**
 30 **\$203,888.**

31 **SECTION 5.** This 2022 Act being necessary for the immediate preservation of the public
 32 peace, health and safety, an emergency is declared to exist, and this 2022 Act takes effect
 33 on its passage.
