## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Increases annual salary of judges of Supreme Court, Court of Appeals, circuit courts and Oregon Tax Court.

Declares emergency, effective on passage.

## A BILL FOR AN ACT

  - beginning on December 1, 2021, and ending on June 30, 2022.
- 9 [(b) On July 1, 2020, the annual salary of the Chief Judge of the Court of Appeals, as adjusted 10 under ORS 292.428, shall be increased by \$5,000.]
  - (b) On July 1, 2022, the annual salary of the Chief Judge of the Court of Appeals shall be \$188,544.
  - (c) On January 1, 2023, the annual salary of the Chief Judge of the Court of Appeals shall be \$213,828.
    - (2)(a) The annual salary of each other judge of the Court of Appeals shall be [\$150,980] \$168,108 for the period beginning on [January 1, 2019, and ending on June 30, 2020] December 1, 2021, and ending on June 30, 2022.
    - [(b) On July 1, 2020, the annual salary of each other judge of the Court of Appeals, as adjusted under ORS 292.428, shall be increased by \$5,000.]
    - (b) On July 1, 2022, the annual salary of each other judge of the Court of Appeals shall be \$184,920.
    - (c) On January 1, 2023, the annual salary of each other judge of the Court of Appeals shall be \$209,724.
      - SECTION 2. ORS 292.411 is amended to read:

- (2)(a) The annual salary of each other judge of the Supreme Court shall be [\$154,040 for the period beginning on January 1, 2019, and ending on June 30, 2020] \$171,408 for the period beginning on December 1, 2021, and ending on June 30, 2022.
- [(b) On July 1, 2020, the annual salary of each other judge of the Supreme Court, as adjusted under ORS 292.428, shall be increased by \$5,000.]
- (b) On July 1, 2022, the annual salary of each other judge of the Supreme Court shall be \$188,544.

  - (2) On July 1, 2022, the annual salary of the judge of the Oregon Tax Court shall be \$179,064.
  - (3) On January 1, 2023, the annual salary of the judge of the Oregon Tax Court shall be \$203,888.
    - SECTION 5. This 2022 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2022 Act takes effect on its passage.
