SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Provides that maximum loading weight of motorboat must be less than 5,000 pounds to obtain towed watersports motorboat certificate.

Authorizes State Marine Board to conduct study related to increasing or decreasing prescribed maximum loading weight.

Provides that person shall carry towed watersports endorsement if engaged in any towed watersports within Newberg Pool Congested Zone. Modifies definitions of "Newberg Pool Congested Zone," "towed watersports" and "wake surfing." Prohibits person from wake surfing or using devices or individuals to increase wakes in Newberg Pool Congested Zone.

Declares emergency, effective on passage.

(3) A towed watersports endorsement and towed watersports motorboat certificate issued under 1 2 this section starts on the day the endorsement or certificate is issued and expires on December 31 of the last year in the two-year period. 3 (4) A person issued a towed watersports endorsement or towed watersports motorboat certificate 4 under this section may renew the endorsement or certificate by: 5 (a) Paying the towed watersports endorsement renewal fee established under ORS 830.646; and 6 (b) Completing an application in the form and manner required by the board by rule. 7 (5) The board shall issue a towed watersports motorboat certificate in the form of a decal. 24	SECTION 4. (1) The State Marine Board may conduct a study on increasing or decreasing
25	the maximum loading weight prescribed in ORS 830.643. If the board undertakes a study, the
26	board shall determine on the basis of objective, peer reviewed scientific research whether
27	increasing or decreasing the maximum loading weight is likely to:
28	(a) Have an adverse effect on the waters, beds and banks of this state;
29	(b) Have an adverse effect on aquatic, nearshore and shoreline habitats, fish and wildlife
30	habitats and salmonid habitats; or
31	(c) Exceed or violate state or federal turbidity limits.
32	(2) Before making a determination, the board shall consult with and receive comments
33	from the Department of State Lands, the State Department of Fish and Wildlife and the
34	Department of Environmental Quality.
35	(3) If the board undertakes a study under this section, the board shall report to the in-
36	terim committees of the Legislative Assembly related to the environment, in the manner
37	provided in ORS 192.245, on the board's research, findings, determinations and recommen-
38	dations, including recommendations for legislative changes, if any.
39	SECTION 5. (1) The amendments to ORS 830.643 by section 1 of this 2022 Act apply to
40	towed watersports motorboat certificates issued, renewed or replaced on or after the effec-
41	tive date of this 2022 Act.
42	(2) The amendments to ORS 830.649 and 830.652 by sections 2 and 3 of this 2022 Act apply
43	to actions occurring on or after the effective date of this 2022 Act.

44 <u>SECTION 6.</u> This 2022 Act being necessary for the immediate preservation of the public 45 peace, health and safety, an emergency is declared to exist, and this 2022 Act takes effect $\rm SB \ 1589$
