**PROPOSED AMENDMENTS TO
HOUSE BILL 4074**

1 On page 1 of the printed bill, line 3, delete “section 13,” and insert
2 “sections 13, 14 and 16,” and after the semicolon insert “repealing sections
3 17 and 26, chapter 103, Oregon Laws 2018;”.

4 On page 3, delete lines 43 through 45 and insert:

5 **“SECTION 10.** Section 16, chapter 103, Oregon Laws 2018, as amended
6 by section 39, chapter 542, Oregon Laws 2021, is amended to read:

7 **“Sec. 16.** [(1)] Notwithstanding ORS [475B.759] **475C.726**, before making
8 any other distribution from the Oregon Marijuana Account established under
9 ORS [475B.759] **475C.726**, the Department of Revenue shall first distribute
10 quarterly from the account the following:

11 “[a] (1) \$875,000 to the Oregon Liquor and Cannabis Commission for
12 deposit in the Marijuana Control and Regulation Fund established under
13 ORS [475B.296] **475C.297**; and

14 “[b] (2) \$750,000 to the Oregon Criminal Justice Commission for deposit
15 into the Illegal Marijuana Market Enforcement Grant Program Fund estab-
16 lished under section 15, chapter 103, Oregon Laws 2018, for the purposes of
17 paying the costs incurred by the commission in carrying out the provisions
18 of section 13, chapter 103, Oregon Laws 2018.

19 “[2] *The final distribution made under subsection (1) of this section shall*
20 *be made in the fiscal quarter beginning on October 1, 2023.*]

21 **“SECTION 11.** Section 14, chapter 103, Oregon Laws 2018, is amended to

1 read:

2 “**Sec. 14. (1)** [*Not later than January 1, 2020, and*] Not later than January
3 1 **of** each year [*thereafter*], the Oregon Criminal Justice Commission shall
4 submit a report in the manner provided in ORS 192.245 on the status and
5 effectiveness of the Illegal Marijuana Market Enforcement Grant Program
6 established under section 13 [*of this 2018 Act*], **chapter 103, Oregon Laws**
7 **2018**, to the interim committees of the Legislative Assembly related to the
8 judiciary.

9 “**(2)** Not later than January 1 of each year, the commission shall
10 submit a report in the manner provided in ORS 192.245 on recommen-
11 dations for changes to the funding of the Illegal Marijuana Market
12 Enforcement Grant Program to the interim committees of the Legis-
13 lative Assembly related to the judiciary. In making the recommen-
14 dations described in this subsection, the commission shall consider the
15 best available information and projections regarding unlawful
16 marijuana cultivation and distribution operations in this state and any
17 human trafficking related to those operations.

18 “**SECTION 12.** Sections 17 and 26, chapter 103, Oregon Laws 2018,
19 are repealed.

20 “**SECTION 13.** There is appropriated to the _____, for the
21 biennium ending June 30, 2023, out of the General Fund, the amount
22 of \$_____ for financial assistance to community-based organizations
23 that are responding to the humanitarian crises associated with un-
24 lawful marijuana cultivation and distribution operations.”.

25 On page 4, delete lines 1 through 3.

26 In line 4, delete “11” and insert “14”.

27 In line 11, delete “12” and insert “15”.
