imum limit for payment of expenses from fees, moneys or other reve-1 nues, including Miscellaneous Receipts, but excluding lottery funds  $\mathbf{2}$ and federal funds, collected or received by the Oregon Criminal Justice 3 Commission, is increased by \$6,000,000, for additional grants under the 4 Illegal Marijuana Market Enforcement Grant Program established  $\mathbf{5}$ under section 13, chapter 103, Oregon Laws 2018, for financial assist-6 ance to community-based organizations that are responding to the 7 humanitarian crises associated with unlawful marijuana cultivation 8 and distribution operations. 9

10 "SECTION 13. Notwithstanding any other law limiting expenditures, 11 the limitation on expenditures established by section 3, chapter 379, 12 Oregon Laws 2021, for the biennium ending June 30, 2023, as the max-13 imum limit for payment of expenses from fees, moneys or other reve-14 nues, including Miscellaneous Receipts, but excluding lottery funds 15 and federal funds, collected or received by the Oregon Criminal Justice 16 Commission, is increased by \$130,978.

17 "SECTION 14. Notwithstanding any other law limiting expenditures, 18 the limitation on expenditures established by section 1 (1), chapter 640, 19 Oregon Laws 2021, for the biennium ending June 30, 2023, as the max-19 imum limit for payment of fees, moneys or other revenues, including 20 Miscellaneous Receipts, but excluding lottery funds and federal funds 21 collected or received by the Oregon Liquor and Cannabis Commission 22 for administrative expenses, is increased by \$155,127.".
