

Requested by JOINT COMMITTEE ON WAYS AND MEANS

**PROPOSED AMENDMENTS TO
B-ENGROSSED HOUSE BILL 4030**

1 On page 1 of the printed B-engrossed bill, line 2, delete “and 342.125”.

2 On page 6, delete lines 44 and 45.

3 On page 7, delete lines 1 through 4 and insert:

4 **“SECTION 8. Notwithstanding any other provision of law, the**
5 **General Fund appropriation made to the Department of Education by**
6 **section 2 (3), chapter 603, Oregon Laws 2021, for the biennium ending**
7 **June 30, 2023, for other K-12 grant-in-aid programs, is increased by**
8 **\$78,162,971, for implementation of section 7 of this 2022 Act.”.**

9 Delete lines 17 through 22 and insert:

10 **“SECTION 11. Notwithstanding any other provision of law, the**
11 **General Fund appropriation made to the Department of Education by**
12 **section 2 (3), chapter 603, Oregon Laws 2021, for the biennium ending**
13 **June 30, 2023, for other K-12 grant-in-aid programs, is increased by**
14 **\$19,540,743, for implementation of section 10 of this 2022 Act.”.**

15 Delete lines 32 through 45 and delete page 8.

16 On page 9, delete lines 1 through 18 and insert:

17 **“NOTE: Section 15 was deleted by amendment. Subsequent sections were**
18 **not renumbered.”.**

19 Delete lines 26 through 31 and insert:

20 **“SECTION 17. In addition to and not in lieu of any other appropri-**
21 **ation, there is appropriated to the Teacher Standards and Practices**

1 **Commission, for the biennium ending June 30, 2023, out of the General**
2 **Fund, the amount of \$320,000, for implementation of section 16 of this**
3 **2022 Act.”.**

4 After line 32, insert:

8 **“SECTION 19. Notwithstanding any other provision of law, the**
9 **General Fund appropriation made to the Department of Education by**
10 **section 1 (1), chapter 603, Oregon Laws 2021, for the biennium ending**
11 **June 30, 2023, for operations, is increased by \$1,623,093, for implemen-**
12 **tation of the provisions of this 2022 Act.**

13 **“SECTION 20. In addition to and not in lieu of any other appropri-**
14 **ation, there is appropriated to the Teacher Standards and Practices**
15 **Commission, for the biennium ending June 30, 2023, out of the General**
16 **Fund, the amount of \$353,193, for implementation of the provisions of**
17 **this 2022 Act.”.**

18 In line 36, delete “19” and insert “21”.

19 In line 42, delete “20” and insert “22”.
