**PROPOSED AMENDMENTS TO
A-ENGROSSED HOUSE BILL 4068**

1 On page 3 of the printed A-engrossed bill, delete lines 43 through 45.

2 On page 4, delete lines 1 and 2 and insert:

3 **“NOTE:** Section 5 was deleted by amendment. Subsequent sections were
4 not renumbered.”.

5 Delete lines 42 through 45 and delete pages 5 and 6.

6 On page 7, delete lines 1 through 12 and insert:

7 **“SECTION 7. (1) The Oregon Homeland Security Council, in con-**
8 **sultation with emergency management agencies, the Oregon Depart-**
9 **ment of Emergency Management or its predecessor office, and the**
10 **Oregon Health Authority, shall develop a plan to ensure that**
11 **Oregonians have access to a robust stockpile of supplies and equip-**
12 **ment for use in an emergency, including personal protective equip-**
13 **ment and raw materials for the sustained manufacture thereof,**
14 **communicable disease testing equipment and all-hazards emergency**
15 **surge supplies, that can be deployed on a regional basis.**

16 **“(2) In developing the plan, the council shall:**

17 **“(a) Develop a comprehensive list of essential equipment, materials,**
18 **supplies, distribution channels and manufacturing capabilities neces-**
19 **sary to accomplish the purpose described in subsection (1) of this sec-**
20 **tion;**

21 **“(b) Determine a statewide standard of availability, sufficient to**

1 adequately protect public health and safety, for each article of per-
2 sonal protective equipment and each element of communicable disease
3 testing equipment on the list;

4 “(c) Establish metrics and processes for real-time, transparent re-
5 porting of materials, supplies, distribution channels and manufactur-
6 ing capabilities for each type of equipment or supply on the list that
7 the council deems to be critical in an emergency;

8 “(d) Collaborate with hospitals, long term care facilities, provider
9 groups and health care organizations to obtain information on the
10 extent to which each entity is able to provide personal protective
11 equipment to personnel who are in contact with patients, including
12 usage rates of personal protective equipment during normal business
13 operations and any additional personal protective equipment each en-
14 tity may maintain for emergency purposes;

15 “(e) Determine a rotation schedule for supplies, equipment and
16 materials in the stockpile; and

17 “(f) Establish quality standards for elements of the stockpile, uti-
18 lizing guidance from the Centers for Disease Control and Prevention
19 and other public health organizations.

20 “(3) On or before April 15, 2023, the council shall report to the
21 Legislative Assembly, in the manner provided by ORS 192.245, on the
22 plan developed under this section. The report must include:

23 “(a) A description of the plan;

24 “(b) An estimate of the cost of implementing the plan, including
25 costs related to communication and coordination between participat-
26 ing entities; and

27 “(c) Recommendations, which may include recommendations for
28 legislation, regarding the implementation, operation and funding of
29 the plan, including a recommendation of the state agency best suited
30 to manage the plan.
