**PROPOSED AMENDMENTS TO  
SENATE BILL 5702**

1 In line 2 of the printed bill, after the semicolon delete the rest of the line  
2 and insert “creating new provisions; amending sections 1 and 3, chapter 659,  
3 Oregon Laws 2021; and declaring an emergency.”.

4 Delete lines 4 through 15 and insert:

5 **“SECTION 1.** Section 1, chapter 659, Oregon Laws 2021, is amended to  
6 read:

7 **“Sec. 1.** Notwithstanding any other law limiting expenditures, the fol-  
8 lowing amounts are established for a six-year period beginning July 1, 2021,  
9 as the maximum limits for payment of expenses from fees, moneys or other  
10 revenues, including Miscellaneous Receipts, but excluding lottery funds and  
11 federal funds, collected or received by the state agencies listed, for the ac-  
12 quisition of land and the acquisition, planning, constructing, altering, re-  
13 pairing, furnishing and equipping of buildings and facilities:

9 **“SECTION 2.** Section 3, chapter 659, Oregon Laws 2021, is amended to  
10 read:

11 **“Sec. 3.** Notwithstanding any other law limiting expenditures, the  
12 amount of [~~\$445,905,100~~] **\$475,905,100** is established for a six-year period be-  
13 ginning July 1, 2021, as the maximum limit for payment of expenses from  
14 fees, moneys or other revenues, including Miscellaneous Receipts, but ex-  
15 cluding lottery funds and federal funds, collected or received by the Higher  
16 Education Coordinating Commission, for expenditures of proceeds from state  
17 bonds issued for the benefit of a public university, pursuant to agreements  
18 between the commission and a public university.

19 **“SECTION 3.** In addition to and not in lieu of any other appropri-  
20 ation, there is appropriated to the Legislative Administration Com-  
21 mittee, for a six-year period beginning July 1, 2021, out of the General  
22 Fund, the amount of \$223,081,000, for the third phase of the Oregon  
23 State Capitol Accessibility, Maintenance and Safety capital improve-  
24 ments.

25 **“SECTION 4.** The Legislative Assembly approves the proposal of the  
26 Oregon Military Department, submitted in accordance with ORS  
27 396.515 (4), for the sale of the Silverton Armory.

28 **“SECTION 5.** This 2022 Act being necessary for the immediate  
29 preservation of the public peace, health and safety, an emergency is  
30 declared to exist, and this 2022 Act takes effect on its passage.”.
