

Testimony on House Bill 4066 House Veterans and Emergency Management Committee February 1, 2022

Chair Grayber, Vice-Chairs Lewis and Meek, and members of the Committee. My name is Kyle Thomas and I am the Director of Legislative and Policy Affairs for the Higher Education Coordinating Commission (HECC). Thank you for the opportunity to submit testimony on HB 4066. My comments are limited to Section 9, the provision addressing Oregon Promise for Oregon National Guard Members.

Section 9 provides that a member of the Oregon National Guard does not need to accept federal financial aid awards in order to receive the Oregon Promise grant. If passed, Oregon National Guard members would be the only program participants not required to accept federal financial aid as a condition of receiving their award. The Oregon Promise financial aid program is what is known as a 'last dollar' program, meaning the benefit applies after the application of other benefits, and provides funds up to the cost of the average tuition and fees at Oregon community colleges. By allowing Oregon National Guard members to decline federal educational aid, the state program pays more to cover the missing federal aid, but the benefit to the student remains the same.

Additionally, Oregon National Guard members in good standing are served by the Oregon National Guard Tuition Assistance Program (ONG-STA), a program that covers the tuition and fee costs of National Guard members, regardless of federal aid, and provides additional awards on top to mitigate other costs of attendance. The only guard members that do not qualify for the ONG-STA program are those who are not active, or who have adverse actions.

HECC has provided a chart that shows the relationship between state and federal financial aid for Oregon National Guard members. This chart illustrates the effect of HB 4066 on a student-guard member's financial aid picture.
