This strategic plan and advocacy by the HITOC stakeholders signal a need for more just, culturally responsive, and inclusive operability within the health care infrastructure that includes eradicating existing silos of sharing, collection, and analysis and allowing practitioners and consumers/patients to have increased ownership and shared responsibility of health care sector in general.
